A BILL ENTITLED

1 AN ACT concerning

2 **Federal-Aid Primary Highways – Signs**

3 FOR the purpose of authorizing the State Highway Administration to issue a permit for a
4 sign along or near a federal-aid primary highway if the sign is a directional sign for
5 a historic, cultural, or educational site that is naturally suited for outdoor recreation;
6 and generally relating to signs erected along or near federal-aid primary highways.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Transportation**

15 8–730.

16 (a) Except as provided in [subsection (b)] **SUBSECTIONS (B) AND (C)** of this
17 section, the Administration may not issue a permit for any outdoor sign along or near any
18 federal-aid primary highway, if the sign:

19 (1) Imitates or resembles any official traffic sign, signal, or device;

20 (2) Is erected or maintained on any tree or painted or drawn on any rock
21 or other natural feature;

22 (3) Is erected or maintained in a way that:

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 (i) Obscures or otherwise interferes with the effectiveness of an
2 official traffic sign, signal, or device; or

3 (ii) Obstructs or interferes with a driver's view of approaching,
4 merging, or intersecting traffic;

5 (4) Is located within 250 feet of any public park, public forest, playground,
6 or cemetery that is adjacent to a federal-aid primary highway; or

7 (5) Is along or near a scenic byway located on the federal-aid primary
8 highway.

9 (b) (1) This subsection applies only in Calvert County and St. Mary's County.

10 (2) The Administration may, in conformance with federal law, issue a
11 permit for an outdoor sign along or near a scenic byway located on a federal-aid primary
12 highway if the sign:

13 (i) Was erected on or before January 1, 2008; or

14 (ii) Is a directional sign for a facility that:

15 1. Sells principally local agricultural or aquacultural
16 products; and

17 2. Is located within a 5-mile radius of the sign.

18 (3) A sign erected under this subsection shall be erected and maintained in
19 a manner that is safe and does not detract from the scenic or cultural character of the scenic
20 byway along which the sign is located.

21 **(C) THE ADMINISTRATION MAY, IN CONFORMANCE WITH FEDERAL LAW,**
22 **ISSUE A PERMIT FOR AN OUTDOOR SIGN ALONG OR NEAR A FEDERAL-AID PRIMARY**
23 **HIGHWAY IF THE SIGN IS A DIRECTIONAL SIGN FOR A HISTORIC, CULTURAL, OR**
24 **EDUCATIONAL SITE THAT IS NATURALLY SUITED FOR OUTDOOR RECREATION.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2016.
