1 AN ACT concerning

2 **Campaign Finance – Ballot Issue Committees – Prospective Questions**

3 FOR the purpose of altering certain campaign finance law definitions to include campaign
4 finance activity relating to prospective questions to be placed on the ballot;
5 prohibiting a chief election official from certifying a petition if the petition sponsor
6 fails to provide proof of filing a certain campaign finance report; repealing certain
7 requirements that a statement of contributions and expenditures for a petition be
8 filed at the time the petition is filed; prohibiting a circulator from collecting
9 signatures for certain petitions until the sponsor of the petition establishes a ballot
10 issue committee; requiring a petition sponsor’s ballot issue committee to file a
11 campaign finance report at the time the petition is filed; requiring a ballot issue
12 committee opposing a prospective question to file a campaign finance report within
13 a certain number of days after the petition to place the question on the ballot is filed;
14 and generally relating to campaign finance activity relating to prospective questions
15 to be placed on the ballot.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Election Law**

14 1–101.

15 (f) “Ballot issue committee” means a political committee that is formed to
16 promote the success or defeat of a question **OR PROSPECTIVE QUESTION** to be submitted
17 to a vote at an election.

18 (k) (1) “Campaign material” means any material that:

19 (i) contains text, graphics, or other images;

20 (ii) relates to a candidate, a prospective candidate, or the approval
21 or rejection of a question **OR PROSPECTIVE QUESTION**; and

22 (iii) is published or distributed.

23 (2) “Campaign material” includes:

24 (i) material transmitted by or appearing on the Internet or other
25 electronic medium; and

26 (ii) an oral commercial campaign advertisement.

27 (o) (1) “Contribution” means the gift or transfer, or promise of gift or transfer,
28 of money or other thing of value to a campaign finance entity to promote or assist in the
29 promotion of the success or defeat of a candidate, political party, [or] question, **OR**
30 **PROSPECTIVE QUESTION**.

31 (2) “Contribution” includes:

1 (i) proceeds from the sale of tickets to a campaign fund-raising
2 event; and

3 (ii) a disbursement or deposit of money or a gift, a subscription, an
4 advance, or anything of value that is made by a person in coordination with, or at the
5 request or suggestion of, a candidate or a campaign finance entity of a candidate.

6 (aa) “Expenditure” means a gift, transfer, disbursement, or promise of money or a
7 thing of value by or on behalf of a campaign finance entity to:

8 (1) promote or assist in the promotion of the success or defeat of a
9 candidate, political party, [or] question, **OR PROSPECTIVE QUESTION** at an election; or

10 (2) pay for the publication expense of a legislative newsletter under Title
11 13, Subtitle 4 of this article.

12 (gg) “Political committee” means a combination of two or more individuals that has
13 as its major purpose promoting the success or defeat of a candidate, political party, [or]
14 question, **OR PROSPECTIVE QUESTION** submitted to a vote at any election.

15 6–208.

16 (a) At the conclusion of the verification and counting processes, the chief election
17 official of the election authority shall:

18 (1) determine whether the validated signatures contained in the petition
19 are sufficient to satisfy all requirements established by law relating to the number and
20 geographical distribution of signatures; and

21 (2) if it has not done so previously, determine whether the petition has
22 satisfied all other requirements established by law for that petition and immediately notify
23 the sponsor of that determination, including any specific deficiencies found.

24 (b) **IF A PETITION SPONSOR’S BALLOT ISSUE COMMITTEE FAILS TO**
25 **PROVIDE PROOF OF FILING THE REPORT REQUIRED UNDER § 13–309(E) OF THIS**
26 **ARTICLE, THE CHIEF ELECTION OFFICIAL MAY NOT CERTIFY THE PETITION.**

27 (C) If the chief election official determines that a petition has satisfied all
28 requirements established by law relating to that petition, the chief election official shall
29 certify that the petition process has been completed and shall:

30 (1) with respect to a petition seeking to place the name of an individual or
31 a question on the ballot, certify that the name or question has qualified to be placed on the
32 ballot;

1 (2) with respect to a petition seeking to create a new political party, certify
2 the sufficiency of the petition to the chairman of the governing body of the partisan
3 organization; and

4 (3) with respect to the creation of a charter board under Article XI–A, § 1A
5 of the Maryland Constitution, certify that the petition is sufficient.

6 [(c)] (D) Notice of a determination under this section shall be provided in
7 accordance with § 6–210 of this subtitle.

9 (c) (1) [At the time of filing a petition under the provisions of Article XI–A or
10 Article XVI of the Maryland Constitution, the person who files the petition shall also file a
11 signed statement, under penalty of perjury, showing the contributions and expenditures
12 for the petition including:

13 (i) the name and post office address of every contributor to the
14 expense of the petition;

15 (ii) the amount contributed by each contributor; and

16 (iii) the name and address of each person to whom any money was
17 paid or promised for providing a service related to the petition.

18 (2) If the statement under paragraph (1) of this subsection is not filed with
19 the petition, the petition may not be certified under § 6–208 of this article.

20 (3) (i) The individual who signed the statement required under
21 paragraph (1) of this subsection] **THE RESPONSIBLE OFFICERS OF A PETITION**
22 **SPONSOR’S BALLOT ISSUE COMMITTEE** shall be a party to any proceeding to test the
23 validity of the petition.

24 [(ii)] (2) The proceeding shall be filed in the county where the
25 [person or association] **PETITION SPONSOR** resides or maintains its principal place of
26 business.

27 13–202.

28 (a) This section does not apply to a candidate for election to the central committee
29 of a political party if the candidate during an election cycle does not:

30 (1) spend more than \$1,000 in personal funds; or

31 (2) accept contributions.

1 (b) Unless otherwise expressly authorized by law, all campaign finance activity
2 for an election under this article shall be conducted through a campaign finance entity.

3 (c) An individual may not file a certificate of candidacy or a declaration of intent
4 under § 5-703 or § 5-703.1 of this article until the individual establishes, or causes to be
5 established, an authorized candidate campaign committee.

6 (D) A CIRCULATOR MAY NOT COLLECT SIGNATURES FOR A PETITION UNDER
7 ARTICLE XI-A, ARTICLE XI-F, OR ARTICLE XVI OF THE MARYLAND
8 CONSTITUTION OR UNDER § 9-205 OF THE LOCAL GOVERNMENT ARTICLE UNTIL
9 THE SPONSOR OF THE PETITION ESTABLISHES A BALLOT ISSUE COMMITTEE.

10 13-309.

11 (E) (1) THIS SUBSECTION APPLIES TO A BALLOT ISSUE COMMITTEE
12 FORMED TO SUPPORT OR OPPOSE A PROSPECTIVE QUESTION UNDER ARTICLE
13 XI-A, ARTICLE XI-F, OR ARTICLE XVI OF THE MARYLAND CONSTITUTION OR §
14 9-205 OF THE LOCAL GOVERNMENT ARTICLE.

15 (2) A PETITION SPONSOR'S BALLOT ISSUE COMMITTEE SHALL FILE A
16 CAMPAIGN FINANCE REPORT AT THE TIME THE PETITION IS FILED UNDER § 6-205
17 OF THIS ARTICLE.

18 (3) A BALLOT ISSUE COMMITTEE OPPOSING A PROSPECTIVE
19 QUESTION SHALL FILE A CAMPAIGN FINANCE REPORT WITHIN 10 BUSINESS DAYS
20 AFTER THE PETITION TO PLACE THE QUESTION ON THE BALLOT IS FILED UNDER
21 § 6-205 OF THIS ARTICLE.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2016.
