Insurance – Self–Funded Student Health Plans

- 3 FOR the purpose of exempting from certain State insurance laws a self-funded student 4 health plan operated by an independent institution of higher education that provides $\mathbf{5}$ health care services to its students and their dependents under certain 6 circumstances; requiring a certain report of an independent institution of higher 7 education to be filed on a certain date: requiring certain certifications to be construed 8 in a certain manner; providing for the application of this Act; making a stylistic 9 change; altering certain definitions; making this Act an emergency measure; and 10 generally relating to self-funded student health plans and State insurance laws.

1 SECTION 2. AND BE IT FURTHER ENACTED, That the first report of an 2 independent institution of higher education required under § 1–202(5) of the Insurance 3 Article, as enacted by Section 1 of this Act, shall be filed with the Maryland Insurance 4 Commissioner on July 1, 2016, and the certifications made in the report shall be construed 5 to cover the time period from July 1, 2015 <u>2016</u>, through June 30, 2016 <u>2017</u>.

6 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall be construed to
7 apply retroactively and shall be applied to and interpreted to affect any self-funded student
8 health plan that is operated by an independent institution of higher education on or after
9 July 1, 2015.

SECTION 4. 3. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three-fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
