## A BILL ENTITLED

1 AN ACT concerning

2 **Wicomico County Board of Education – Election and Appointment of Members**

3 FOR the purpose of requiring that, beginning with a certain election, certain members of  
4 the Wicomico County Board of Education be elected by districts and certain members  
5 be elected at large; providing that, alternatively, beginning with a certain election,  
6 certain members of the Wicomico County Board of Education be elected by districts  
7 and certain members be appointed; establishing the composition of the county board;  
8 providing for the qualifications, terms of office, and filling of a vacancy of certain  
9 members of the county board; establishing certain removal, hearing, and appeal  
10 procedures for certain members of the county board; establishing a Wicomico County  
11 School Board Nominating Commission to select nominees to be recommended to the  
12 Wicomico County Council to fill certain appointments or vacancies on the county  
13 board; providing for the membership and duties of the Commission; repealing certain  
14 provisions concerning the appointment by the Governor of the members of the  
15 Wicomico County Board of Education; providing for the termination of the terms of  
16 certain members of the county board; submitting this Act to a referendum of the  
17 qualified voters of Wicomico County for their adoption or rejection of certain  
18 provisions of this Act; and generally relating to the election and appointment of the  
19 members of the Wicomico County Board of Education.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
That the Laws of Maryland read as follows:

**Article – Education**

3–105.

(a) Subsections (b), (c), and (d) of this section do not apply to a county if the number of members of the county board is regulated by other provisions of this title.

(b) If a county school system has an enrollment of less than 50,000 students, the county board shall have five members, except that:

(1) The Worcester County Board shall have the number of members provided in subsection (e) of this section; AND

(2) Any county board that had more than five members on July 1, 1969, shall retain that number of members[; and

(3) The Wicomico County Board shall have the number of members provided in subsection (f) of this section].

(c) If a county school system has an enrollment of 50,000 students or more but less than 100,000 students, the county board shall have seven members.

(d) If a county school system has an enrollment of 100,000 students or more, the county board shall have nine members except as provided in § 3–901 of this title for Montgomery County and § 3–1002 of this title for Prince George’s County.

(e) The Worcester County Board consists of seven voting members and one nonvoting student member from each public high school in the county.

[(f) (1) The Wicomico County Board consists of seven members.

(2) The term of a member is 5 years.]

16 (b) In Baltimore County, in accordance with Subtitle 2A of this title, the members  
17 of the county board shall be a combination of members who are elected and appointed.

18 (c) In Caroline County, in accordance with Subtitle 3A of this title, the members  
19 of the county board shall be a combination of members who are elected and appointed.

20 (d) In Harford County, in accordance with Subtitle 6A of this title, the members  
21 of the county board shall be a combination of members who are elected and appointed.

22 (e) In Prince George's County, in accordance with Subtitle 10 of this title, the  
23 members of the county board shall be a combination of members who are elected and  
24 appointed.

25 (f) An individual subject to the authority of the county board may not serve as a  
26 member of the county board. At the time of filing a certificate of candidacy for election to a  
27 county board, a person shall certify to the local board of supervisors of elections whether or

1 not the person is subject to the authority of the county board. The Governor may not issue  
2 a commission of election to a person who has certified affirmatively and who is elected to a  
3 county board until the member-elect offers proof that the member-elect is no longer subject  
4 to the authority of the county board.

5 (g) The election of the county boards shall be held as provided in Subtitles 2  
6 through 14 of this title and the Election Law Article.

9 (A) (1) THE WICOMICO COUNTY BOARD CONSISTS OF SEVEN  
10 NONPARTISAN ELECTED VOTING MEMBERS.

11 (2) THE SEVEN MEMBERS SHALL BE ELECTED AS FOLLOWS:

12 (I) ONE MEMBER FROM EACH OF THE FIVE COUNCILMANIC  
13 DISTRICTS IN THE COUNTY, ELECTED BY THE VOTERS OF THAT DISTRICT; AND

14 (II) TWO MEMBERS AT LARGE, ELECTED BY THE VOTERS OF THE  
15 COUNTY.

16 (B) (1) A CANDIDATE WHO BECOMES AN ELECTED MEMBER OF THE  
17 COUNTY BOARD MUST BE A RESIDENT AND REGISTERED VOTER OF WICOMICO  
18 COUNTY.

19 (2) (I) AN ELECTED MEMBER WHO NO LONGER RESIDES IN  
20 WICOMICO COUNTY MAY NOT CONTINUE AS A MEMBER OF THE BOARD.

21 (II) A MEMBER ELECTED FROM A COUNCILMANIC DISTRICT  
22 WHO NO LONGER RESIDES IN THAT DISTRICT MAY NOT CONTINUE AS A MEMBER OF  
23 THE BOARD.

24 (3) IF THE BOUNDARY LINE OF A WICOMICO COUNTY COUNCILMANIC  
25 DISTRICT IS CHANGED, THE TERM OF AN INCUMBENT MEMBER OF THE COUNTY  
26 BOARD WHO NO LONGER RESIDES IN THAT COUNCILMANIC DISTRICT BECAUSE OF  
27 THE CHANGE IS NOT AFFECTED DURING THIS TERM.

29 (A) THE SEVEN MEMBERS OF THE WICOMICO COUNTY BOARD SHALL BE  
30 ELECTED:

1           **(1) AT THE GENERAL ELECTION IN 2018 AND AT THE GENERAL**  
2 **ELECTION EVERY 4 YEARS THEREAFTER; AND**

3           **(2) IN ACCORDANCE WITH § 3-13A-01 OF THIS SUBTITLE AND TITLE**

28 **SHALL HOLD A PUBLIC HEARING REGARDING THE NOMINEES.**

1                   **(II) AFTER THE HEARING, IF THE COUNTY COUNCIL DEEMS AT**  
2 **LEAST ONE OF THE NOMINEES ACCEPTABLE, THE COUNTY COUNCIL SHALL VOTE ON**  
3 **THE NOMINEES AND FILL THE VACANCY.**

4                   **(III) IF THE COUNTY COUNCIL DEEMS BOTH NOMINEES**  
5 **UNACCEPTABLE, THE COUNTY COUNCIL SHALL RETURN THE NAMES TO THE**  
6 **COMMISSION AND REQUEST THAT THE COMMISSION SUBMIT THE NAMES OF AT**  
7 **LEAST TWO ADDITIONAL QUALIFIED NOMINEES FROM WHICH THE COUNTY**  
8 **COUNCIL SHALL SELECT AN INDIVIDUAL TO FILL THE VACANCY.**

9                   **(5) (I) THE COMMISSION CONSISTS OF 14 MEMBERS.**

10                   **(II) THE MEMBERS OF THE COMMISSION SHALL BE APPOINTED**  
11 **BY THE COUNTY EXECUTIVE OF WICOMICO COUNTY, SUBJECT TO CONFIRMATION**  
12 **BY THE COUNTY COUNCIL, FROM THE NAMES SUBMITTED BY THE FOLLOWING**  
13 **ORGANIZATIONS, ENTITIES, OR COMMUNITIES OF INTEREST:**

14                   **1. ONE MEMBER FROM THE WICOMICO COUNTY**  
15 **BRANCH OF THE NATIONAL ASSOCIATION FOR THE ADVANCEMENT OF COLORED**  
16 **PEOPLE;**

17                   **2. ONE MEMBER FROM THE WICOMICO COUNTY**  
18 **EDUCATION ASSOCIATION;**

19                   **3. ONE MEMBER FROM THE WICOMICO COUNTY AREA**  
20 **CHAMBERS OF COMMERCE, SELECTED BY THE CHAMBERS BY CONSENSUS;**

21                   **4. ONE MEMBER FROM THE WICOMICO COUNTY**  
22 **EDUCATIONAL SUPPORT PROFESSIONALS ASSOCIATION;**

28 **SPECIAL NEEDS IN THE WICOMICO COUNTY PUBLIC SCHOOL SYSTEM AND WHO IS**  
29 **AFFILIATED WITH AN ADVOCACY GROUP FOR CHILDREN WITH SPECIAL NEEDS IN**  
30 **THE COUNTY.**

31                   **(6) TO THE EXTENT PRACTICABLE, THE COMMISSION SHALL**  
32 **REFLECT THE GENDER, ETHNIC, AND RACIAL MAKEUP OF THE COUNTY.**

1           **(7) THE COUNTY EXECUTIVE OF WICOMICO COUNTY SHALL APPOINT**  
2 **THE MEMBERS OF THE COMMISSION, WITH THE ADVICE AND CONSENT OF THE**  
3 **COUNTY COUNCIL, FROM THE NAMES SUBMITTED BY THE ORGANIZATIONS,**  
4 **ENTITIES, OR COMMUNITIES OF INTEREST LISTED UNDER PARAGRAPH (5) OF THIS**  
5 **SUBSECTION.**

6           **(8) THE TERM OF A MEMBER OF THE COMMISSION IS 4 YEARS.**

7           **(9) THE COMMISSION SHALL SELECT A CHAIR AND VICE CHAIR FROM**  
8 **AMONG THE MEMBERS.**

9           **(B) THE WICOMICO COUNTY PUBLIC SCHOOL SYSTEM SHALL PROVIDE**  
10 **STAFF FOR THE COMMISSION.**

16 **APPOINTED MEMBER AND WITHIN 30 DAYS AFTER THE GENERAL ELECTION; OR**

18 **UNDER THIS SUBTITLE.**

19                   **(3) (I) A MEMBER FROM A DISTRICT MUST BE AT LEAST 21 YEARS**  
20 **OLD, A RESIDENT OF THAT DISTRICT FOR AT LEAST 2 YEARS, AND A REGISTERED**  
21 **VOTER OF THE COUNTY BEFORE THE ELECTION.**

22                   **(II) A MEMBER FROM A DISTRICT WHO DOES NOT MAINTAIN**  
23 **RESIDENCY IN THAT DISTRICT MAY NOT CONTINUE AS A MEMBER OF THE COUNTY**  
24 **BOARD AND THE OFFICE SHALL BE DEEMED VACANT.**

8 COUNCIL SHALL APPOINT A MEMBER FROM A LIST OF NOMINEES SUBMITTED BY THE  
9 WICOMICO COUNTY SCHOOL BOARD NOMINATING COMMISSION TO FILL THAT  
10 VACANCY NO LATER THAN 30 DAYS AFTER THE GENERAL ELECTION.

17           **2. ONE MEMBER FROM THE WICOMICO COUNTY**  
18 **EDUCATION ASSOCIATION;**

19           **3. ONE MEMBER FROM THE WICOMICO COUNTY AREA**  
20 **CHAMBERS OF COMMERCE, SELECTED BY THE CHAMBERS BY CONSENSUS;**

21           **4. ONE MEMBER FROM THE WICOMICO COUNTY**  
22 **EDUCATIONAL SUPPORT PROFESSIONALS ASSOCIATION;**

12           **(A) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A MEMBER OF**  
13 **THE COUNTY BOARD SERVES FOR A TERM OF 4 YEARS BEGINNING ON THE FIRST**  
14 **MONDAY IN DECEMBER, IN THE YEAR IN WHICH THE GOVERNOR IS ELECTED, AFTER**  
15 **THE MEMBER'S ELECTION OR APPOINTMENT AND UNTIL A SUCCESSOR IS ELECTED**  
16 **OR APPOINTED AND QUALIFIES.**

17           **(2) (I) THE INITIAL TERM OF THE TWO MEMBERS AT LARGE OF THE**  
18 **COUNTY BOARD WHOSE TERM BEGINS IN DECEMBER 2018 IS 2 YEARS.**

19           **(II) THE SUCCESSORS OF THE TWO MEMBERS AT LARGE SHALL**  
20 **BE APPOINTED IN 2020 AND BE APPOINTED EVERY 4 YEARS THEREAFTER FOR A**

30           **(2) MISCONDUCT IN OFFICE;**

1           **(3) INCOMPETENCY;**

3           **(5) FAILURE TO ATTEND, WITHOUT GOOD CAUSE, AT LEAST 75% OF**

18           **AT THE FIRST MEETING OF THE COUNTY BOARD IN DECEMBER OF EACH YEAR,**  
19 **THE COUNTY BOARD SHALL ELECT A CHAIR AND VICE CHAIR FROM AMONG THE**  
20 **MEMBERS.**

21           SECTION 3. AND BE IT FURTHER ENACTED, That the terms of the members of  
22 the Wicomico County Board of Education in office at the end of December 2, 2018, shall  
23 expire at the end of December 2, 2018.

24           SECTION 4. AND BE IT FURTHER ENACTED, That before this Act becomes  
25 effective it shall first be submitted to a referendum of the qualified voters of Wicomico  
26 County at the general election to be held in November of 2016. The cost of the election shall  
27 be paid by the County governing body. The County governing body and the Wicomico  
28 County Board of Elections shall do those things necessary and proper to provide for and  
29 hold the referendum required by this section. There shall be printed on the ballot to be used  
30 at this election the title of this Act and underneath the title, on separate lines, a square or  
31 box for each of the following questions:

1 Question 1: “For Retaining the Current System, a Board of Education with Seven  
2 Members Appointed by the Governor”;

3 Question 2: “For a Board of Education with Five Members Elected by District and  
4 Two Members Elected At Large”; and

5 Question 3: “For a Board of Education with Five Members Elected by District and  
6 Two Members Appointed by the Wicomico County Council”.

7 A voter may cast a vote only on one of the questions.

8 If the highest number of the votes cast on the three questions is “For Retaining the  
9 Current System, a Board of Education with Seven Members Appointed by the Governor”,  
10 the provisions of Sections 1, 2, and 3 of this Act are of no effect and null and void. If the  
11 highest number of votes cast on the three questions is “For a Board of Education with Five  
12 Members Elected by District and Two Members Elected At Large”, the provisions of Section  
13 2 of this Act are of no effect and null and void. If the highest number of votes cast on the  
14 three questions is “For a Board of Education with Five Members Elected by District and  
15 Two Members Appointed by the Wicomico County Council”, the provisions of Section 1 of  
16 this Act are of no effect and null and void.

17 SECTION 5. AND BE IT FURTHER ENACTED, That, subject to the provisions of  
18 Section 4 of this Act and for the sole purpose of providing for the referendum required by  
19 Section 4 of this Act, this Act shall take effect July 1, 2016.
