(2)"Economically disadvantaged background" means a family whose income would make a child eligible for free or reduced price meals if the child were in kindergarten. "Eligible child" means a child: (3)Who is from an economically disadvantaged background; (i) Whose parent or guardian seeks to enroll the child in a public (ii) prekindergarten program; and Who is 4 years old on September 1 of the school year in which the (iii) parent or legal guardian seeks to enroll the child in a public prekindergarten program. (4)"Eligible for free or reduced price meals" means eligible for free or reduced price meals based on eligibility requirements established by the United States Department of Agriculture. By the 2007–2008 school year, all eligible children shall be admitted free of (b) charge to publicly funded prekindergarten programs established by each of the county boards. SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2016.
