A BILL ENTITLED

1 AN ACT concerning

2 **Chesapeake Bay Water Transportation Network**

3 FOR the purpose of requiring the Department of Transportation and the Maryland Transit
4 Administration to study and examine the feasibility and practicality of using the
5 Chesapeake Bay and its navigable waters as a water transportation network to link
6 waterfront communities along the Chesapeake Bay; requiring the Department and
7 the Administration to prepare a certain inventory of facilities on the Chesapeake
8 Bay; requiring the Department and the Administration to estimate the cost of
9 implementing a Chesapeake Bay Water Transportation Network; making a stylistic
10 change; providing for the termination of this Act; and generally relating to the
11 Chesapeake Bay Water Transportation Network.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Transportation**

20 8–102.

21 (a) It is the policy of this title to promote an efficient and economical
22 transportation system.

1 (b) The Department [of Transportation] and the State Highway Administration
2 may not proceed to the final project planning phase unless it has been determined that the
3 objective of the proposed project cannot be reasonably achieved through:

4 (1) Improvements in highway maintenance and safety;

5 (2) Projects that modify existing highways but provide for minimal
6 relocation or new highway construction; and

7 (3) Improvements in, or adoption of, transit alternatives, including mass
8 transit alternatives.

9 (c) **AS PART OF THE STRATEGY TO DEVELOP AND PROMOTE AN EFFICIENT
10 AND ECONOMICAL TRANSPORTATION SYSTEM, THE DEPARTMENT AND THE
11 MARYLAND TRANSIT ADMINISTRATION SHALL:**

12 **(1) STUDY AND EXAMINE THE FEASIBILITY AND PRACTICALITY OF
13 USING THE CHESAPEAKE BAY AND ITS NAVIGABLE WATERS AS A WATER
14 TRANSPORTATION NETWORK TO LINK WATERFRONT COMMUNITIES ALONG THE
15 CHESAPEAKE BAY BY USING HIGH-SPEED WATER TAXIS AND OTHER VESSELS TO
16 TRANSPORT RESIDENTS AND VISITORS TO EMPLOYMENT CENTERS, RECREATIONAL
17 FACILITIES, AND ACTIVITIES ALONG THE CHESAPEAKE BAY;**

18 **(2) PREPARE AN INVENTORY OF FACILITIES ON THE CHESAPEAKE
19 BAY THAT MIGHT BE USED IN CONNECTION WITH THE TRANSPORT OF RESIDENTS
20 AND VISITORS BETWEEN WATERFRONT COMMUNITIES ALONG THE CHESAPEAKE
21 BAY;**

22 **(3) ESTIMATE THE COST OF IMPLEMENTING A CHESAPEAKE BAY
23 WATER TRANSPORTATION NETWORK FOR THE TRANSPORT OF RESIDENTS AND
24 VISITORS BY WATER TAXIS AND OTHER VESSELS BETWEEN WATERFRONT
25 COMMUNITIES ALONG THE CHESAPEAKE BAY; AND**

26 **(4) ON OR BEFORE JUNE 30, 2018, REPORT ITS FINDINGS TO THE
27 GOVERNOR AND, IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT
28 ARTICLE, THE GENERAL ASSEMBLY.**

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
30 1, 2016. It shall remain effective for a period of 2 years and, at the end of June 30, 2018,
31 with no further action required by the General Assembly, this Act shall be abrogated and
32 of no further force and effect.
