19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

6 (ii) if the claimant is not eligible under § 8-802 of this subtitle for
7 that weekly benefit amount but was paid wages to qualify in 1 of the next 6 lower lines of
8 the schedule, the weekly benefit amount in the next lower line in column (B) of the schedule.

37 (c) The schedule of benefits that is in effect on the 1st day of a claimant's benefit
38 year applies to the claimant throughout that benefit year.

39 (d) (1) Except as provided in § 8–1207 of this title for the work sharing
40 program and § 8–1604 of this title for the Self–Employment Assistance Program, an eligible
41 claimant shall be paid a weekly benefit amount that is computed by:

42 (i) determining the claimant's weekly benefit amount under this

1 (ii) adding any allowance for a dependent to which the claimant is
2 entitled under § 8–804 of this subtitle; and

3 (iii) subtracting any wages exceeding \$50 payable to the claimant for
4 the week.

5 (2) In computing benefits under this subsection, a fraction of a dollar shall
6 be rounded to the next lower dollar.

7 (e) Any child support payment that is required under § 8–807 of this subtitle shall
8 be withheld from benefits.

9 SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall take
10 effect January 1, 2017, and shall apply to all claims filed establishing a new benefit year
11 on or after January 2, 2017.

12 SECTION 4. AND BE IT FURTHER ENACTED, That, if the Department of Labor,
13 Licensing, and Regulation determines on September 30, 2017, the ratio between the
14 Unemployment Insurance Fund balance and the total taxable wages for the four completed
15 calendar quarters immediately preceding September 30, 2017, is equal to or less than 4.5%:

16 (1) the provisions of Section 2 of this Act shall be null and void without the
17 necessity of further action by the General Assembly; and

18 (2) the Department of Labor, Licensing, and Regulation shall notify the
19 Department of Legislative Services within 15 days of that determination.

20 SECTION 5. AND BE IT FURTHER ENACTED, That, subject to Section 4 of this
21 Act, Section 2 of this Act shall take effect January 1, 2018, and shall apply to all claims
22 filed establishing a new benefit year on or after January 1, 2018.

23 SECTION 6. AND BE IT FURTHER ENACTED, That, except as provided in
24 Sections 3, 4, and 5 of this Act, this Act shall take effect January 1, 2017.
