## A BILL ENTITLED

1 AN ACT concerning

2 **Primary and Secondary Education – Health and Safety – Sugar-Free Schools**  
3 **Act**

4 FOR the purpose of requiring certain county boards to develop a certain plan on or before  
5 a certain date for reducing students' total sugar intake per school meal based on  
6 certain recommendations; requiring certain county boards to convene a certain  
7 workgroup to assist with the development of a certain plan; providing for the  
8 membership of a certain workgroup; requiring the workgroup to make certain  
9 recommendations; requiring a certain workgroup to hold a certain number of public  
10 hearings and provide a certain opportunity for public testimony; and generally  
11 relating to the Sugar-Free Schools Act.

14 Section 7-438

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

19 **Article – Education**

20 **7-438.**

21 **(A) ON OR BEFORE AUGUST 1, 2017, EACH COUNTY BOARD SHALL DEVELOP**  
22 **A PLAN FOR REDUCING STUDENTS' TOTAL SUGAR INTAKE PER SCHOOL MEAL BASED**  
23 **ON RECOMMENDATIONS FROM:**

1           **(1) THE AMERICAN HEART ASSOCIATION; AND**

2           **(2) THE WORKGROUP ESTABLISHED UNDER SUBSECTION (B) OF THIS**  
3 **SECTION.**

4           **(B) (1) EACH COUNTY BOARD SHALL CONVENE A WORKGROUP TO:**

5                   **(I) STUDY THE BEST PRACTICES OF OTHER JURISDICTIONS**  
6 **REGARDING METHODS OF LOWERING STUDENTS' TOTAL SUGAR INTAKE PER**  
7 **SCHOOL MEAL;**

8                   **(II) CONSIDER WHETHER THE RESULTS OF THE BEST**  
9 **PRACTICES STUDY WOULD BE APPROPRIATE TO IMPLEMENT IN THE LOCAL SCHOOL**  
10 **SYSTEM; AND**

11                   **(III) MAKE RECOMMENDATIONS TO THE COUNTY BOARD BASED**  
12 **ON:**

13                           **1. THE RESULTS OF THE BEST PRACTICES STUDY;**

14                           **2. WORKGROUP DISCUSSIONS AND DELIBERATIONS;**

15 **AND**

16                           **3. PUBLIC TESTIMONY RECEIVED AT THE WORKGROUP'S**  
17 **PUBLIC HEARINGS.**

18                   **(2) (I) THE WORKGROUP SHALL INCLUDE PARENTS, STUDENTS,**  
19 **TEACHERS, SCHOOL ADMINISTRATORS, MEDICAL PROFESSIONALS, AND NONPROFIT**  
20 **ORGANIZATIONS.**

21                   **(II) A MEMBER OF THE WORKGROUP MUST BE A RESIDENT OF**  
22 **THE COUNTY IN WHICH THE COUNTY BOARD IS LOCATED.**

23                   **(3) THE WORKGROUP SHALL HOLD AT LEAST TWO PUBLIC HEARINGS**  
24 **AND PROVIDE AN OPPORTUNITY FOR PUBLIC TESTIMONY AT EACH MEETING.**

25           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
26 1, 2016.
