11 12 13 14	(2) The State Board shall tabulate and analyze the results of all case reviews conducted under subsection (a) of this section and submit the results and findings for consideration as part of the local department self–assessment process in \S 5–1309 of this title.
15 16 17	(3) The State Board shall tabulate and analyze the results of all case reviews, both on a jurisdictional and a statewide basis, and submit the results and findings to the Department on a quarterly basis.
18	(c) The State Board shall:
19	(1) provide for public outreach and comment; and
20 21	(2) make available to the public systemic findings and recommendations of the State Board, the local citizen review panel, if any, and the local boards.
