A BILL ENTITLED

1 AN ACT concerning

Department of Agriculture – Bees, Bee Colonies, and Used Bee Equipment – Transportation and Shipment

FOR the purpose of repealing the requirement that a bee colony or used bee equipment
shipped or transported into the State be accompanied by an entry permit issued by
the Department of Agriculture; requiring a certain person to submit certain
information to the Department before shipping or transporting a bee colony or used
bee equipment into the State; authorizing the Department to restrict the movement
of a bee or bee colony under certain circumstances; and generally relating to the
shipment or transportation of a bee, bee colony, or used bee equipment into the State.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

1 (e) A person, who receives a delivery of a colony or bee that was transported into 2 this State without the [documents] **DOCUMENT** required under this subtitle, immediately 3 shall give to the Department notice of the delivery.

4 (f) (1) Any colony or bee that is transported into this State [and that is not 5 accompanied by the documents required under this] IN A MANNER THAT DOES NOT MEET 6 THE REQUIREMENTS OF THIS subtitle shall be restricted to an area that the Department 7 designates and may not be moved.

8 (2) The Department shall give the owner notice that unless the colony or 9 bee is removed from the State within 24 hours, it may be destroyed by the Department at 10 the expense of the owner.

11 (3) The Department may destroy at the expense of the owner any bee or 12 colony that is not removed from this State within 24 hours after notice is given under this 13 subsection.

14 (g) A transportation company or common carrier shall have the immunity from 15 liability described under § 5–415 of the Courts and Judicial Proceedings Article.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 October 1, 2016.
