# A BILL ENTITLED

#### 1 AN ACT concerning

#### 2 Creation of a State Debt – Montgomery County – Maryland SoccerPlex Fields

FOR the purpose of authorizing the creation of a State Debt not to exceed \$750,000, the
proceeds to be used as a grant to the Board of Directors of the Maryland Soccer
Foundation, Inc. for certain development or improvement purposes; providing for
disbursement of the loan proceeds, subject to a requirement that the grantee provide
and expend a matching fund; establishing a deadline for the encumbrance or
expenditure of the loan proceeds; and providing generally for the issuance and sale
of bonds evidencing the loan.

## 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 11 That:

12The Board of Public Works may borrow money and incur indebtedness on (1)behalf of the State of Maryland through a State loan to be known as the Montgomery 1314County – Maryland SoccerPlex Fields Loan of 2016 in a total principal amount equal to the 15lesser of (i) \$750,000 or (ii) the amount of the matching fund provided in accordance with 16Section 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of State 17general obligation bonds authorized by a resolution of the Board of Public Works and issued, sold, and delivered in accordance with §§ 8-117 through 8-124 and 8-131.2 of the 1819State Finance and Procurement Article.

20 (2) The bonds to evidence this loan or installments of this loan may be sold as a 21 single issue or may be consolidated and sold as part of a single issue of bonds under § 22 8–122 of the State Finance and Procurement Article.

(3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and first shall be applied to the payment of the expenses of issuing, selling, and delivering the bonds, unless funds for this purpose are otherwise provided, and then shall be credited on the books of the Comptroller and expended, on approval by the Board of Public Works, for the following public purposes, including any applicable architects' and engineers' fees: as a

1 grant to the Board of Directors of the Maryland Soccer Foundation, Inc. (referred to 2 hereafter in this Act as "the grantee") for the acquisition, planning, design, construction, 3 repair, renovation, reconstruction, and capital equipping of soccer fields at the Maryland 4 SoccerPlex, located in Montgomery County.

5 (4) An annual State tax is imposed on all assessable property in the State in rate 6 and amount sufficient to pay the principal of and interest on the bonds, as and when due 7 and until paid in full. The principal shall be discharged within 15 years after the date of 8 issuance of the bonds.

9 Prior to the payment of any funds under the provisions of this Act for the (5)10 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching 11 fund. No part of the grantee's matching fund may be provided, either directly or indirectly, 12from funds of the State, whether appropriated or unappropriated. No part of the fund may 13consist of real property. The fund may consist of in kind contributions or funds expended 14prior to the effective date of this Act. In case of any dispute as to the amount of the matching 15fund or what money or assets may qualify as matching funds, the Board of Public Works 16 shall determine the matter and the Board's decision is final. The grantee has until June 1, 172018, to present evidence satisfactory to the Board of Public Works that a matching fund will be provided. If satisfactory evidence is presented, the Board shall certify this fact and 1819the amount of the matching fund to the State Treasurer, and the proceeds of the loan equal 20to the amount of the matching fund shall be expended for the purposes provided in this Act. 21Any amount of the loan in excess of the amount of the matching fund certified by the Board 22of Public Works shall be canceled and be of no further effect.

(6) The proceeds of the loan must be expended or encumbered by the Board of Public Works for the purposes provided in this Act no later than June 1, 2023. If any funds authorized by this Act remain unexpended or unencumbered after June 1, 2023, the amount of the unencumbered or unexpended authorization shall be canceled and be of no further effect. If bonds have been issued for the loan, the amount of unexpended or unencumbered bond proceeds shall be disposed of as provided in § 8–129 of the State Finance and Procurement Article.

30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
 31 1, 2016.
