A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Insurance Commissioner – Responsibility for Holding Hearings**
3 **– Delegation**

4 FOR the purpose of altering the authority of the Maryland Insurance Commissioner to
5 delegate to certain persons the responsibility for holding a hearing under certain
6 provisions of law; and generally relating to the authority of the Maryland Insurance
7 Commissioner to hold hearings.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Insurance**

16 2–210.

17 (a) (1) The Commissioner may hold hearings that the Commissioner considers
18 necessary for any purpose under this article.

19 (2) The Commissioner shall hold a hearing:

20 (i) if required by any provision of this article; or

21 (ii) except as otherwise provided in this article, on written demand
22 by a person aggrieved by any act of, threatened act of, or failure to act by the Commissioner

1 or by any report, regulation, or order of the Commissioner, except an order to hold a hearing
2 or an order resulting from a hearing.

3 (b) (1) A demand for a hearing shall state the grounds for the relief to be
4 demanded at the hearing.

5 (2) Within 30 consecutive days after receiving a demand for a hearing, the
6 Commissioner shall:

7 (i) grant and, unless postponed by mutual consent of the parties,
8 hold the hearing; or

9 (ii) issue an order refusing the hearing.

10 (3) If the Commissioner does not grant or refuse a hearing within the
11 30-day period, the hearing is deemed to have been refused.

12 (c) (1) Except as provided in paragraph (2) of this subsection, a hearing held
13 under this section shall be conducted in accordance with Title 10, Subtitle 2 of the State
14 Government Article (Administrative Procedure Act – Contested Cases).

15 (2) A hearing held under this section is not subject to § 10–216 of the State
16 Government Article.

17 (d) The Commissioner may delegate to the Deputy Commissioner, [an associate
18 deputy commissioner, or] an associate commissioner, **OR ANY OTHER PERSON**
19 **DESIGNATED BY THE COMMISSIONER** the responsibility for holding a hearing under this
20 section or § 4–114 of this article.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
22 1, 2016.
