A member of the Commission: 25(e) 26 may not receive compensation as a member of the Commission; but (1) 27 is entitled to reimbursement for expenses under the Standard State 28Travel Regulations, as provided in the State budget.
- 29 (f) The Commission shall meet at least two times each year at the times and 30 places determined by the Commission.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2016.
