A BILL ENTITLED

1 AN ACT concerning

2 **Teachers' Retirement and Pension Systems – Reemployment of Retirees –**
3 **Clarification**

4 FOR the purpose of clarifying the number of retirees of the Teachers' Retirement System
5 or the Teachers' Pension System that are exempt from a certain offset of a retirement
6 allowance if they are reemployed in certain positions in a local school system or the
7 Maryland School for the Deaf; and generally relating to the reemployment of retirees
8 of the teachers' retirement and pension systems.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – State Personnel and Pensions**

23 22–406.

1 (c) (4) Except for an individual whose allowance is subject to a reduction as
2 provided under paragraphs (1)(iii) and (3) of this subsection, the reduction of an allowance
3 under this subsection does not apply to:

4 (iv) a retiree of the Teachers' Retirement System:

5 1. who retired and was reemployed by a participating
6 employer other than the State on or before September 30, 1994; and

7 2. whose employment compensation does not derive, in whole
8 or in part, from State funds;

9 (v) a retiree of the Teachers' Retirement System who:

10 1. is or has been certified to teach in the State;

11 2. has verification of satisfactory or better performance in
12 the last assignment prior to retirement;

13 3. based on the retired teacher's qualifications, has been
14 appointed in accordance with § 4-103 of the Education Article; and

15 4. receives verification of satisfactory or better performance
16 each year the teacher is employed under paragraph (5) of this subsection;

17 (vi) a retiree of the Teachers' Retirement System who:

18 1. A. was employed as a principal within 5 years of
19 retirement; or

20 B. was employed as a principal not more than 10 years before
21 retirement and was employed in a position supervising principals in the retiree's last
22 assignment prior to retirement;

23 2. has verification of satisfactory performance for each year
24 as a principal and, if applicable, in a position supervising principals prior to retirement;

25 3. based on the retiree's qualifications, has been hired as a
26 principal; and

27 4. receives verification of satisfactory performance each year
28 the retiree is employed as a principal under paragraph (6) of this subsection;

29 (xi) a retiree of the Teachers' Retirement System who is reemployed
30 by a local school system or the Maryland School for the Deaf and is rehired in accordance
31 with subsection (c)(8) of this section.

1 (5) (i) An individual who is rehired under paragraph (4)(v) of this
2 subsection shall be employed as a classroom teacher, substitute classroom teacher, or
3 teacher mentor in:

4 1. a public school that:

5 A. is not making adequate yearly progress or is a school in
6 need of improvement as defined under the federal No Child Left Behind Act of 2001 and as
7 implemented by the State Department of Education;

8 B. is receiving funds under Title 1 of the federal No Child Left
9 Behind Act of 2001;

10 C. has more than 50% of the students attending that school
11 who are eligible for free and reduced-price meals established by the United States
12 Department of Agriculture; or

13 D. provides an alternative education program for adjudicated
14 youths or students who have been expelled, suspended, or identified for suspension or
15 expulsion from a public school; or

16 2. the Maryland School for the Deaf.

17 (ii) An individual rehired at a school described under subparagraph
18 (i) of this paragraph shall teach:

19 1. in an area of critical shortage;

20 2. a special education class for students with special needs;
21 or

22 3. a class for students with limited English proficiency.

23 (6) An individual who is rehired under paragraph (4)(vi) of this subsection
24 shall be employed as a principal at:

25 (i) a public school that:

26 1. is not making adequate yearly progress or is a school in
27 need of improvement as defined under the federal No Child Left Behind Act of 2001 and as
28 implemented by the State Department of Education;

29 2. is receiving funds under Title 1 of the federal No Child Left
30 Behind Act of 2001;

1 3. has more than 50% of the students attending that school
2 who are eligible for free and reduced-price meals established by the United States
3 Department of Agriculture; or

4 4. provides an alternative education program for adjudicated
5 youths or students who have been expelled, suspended, or identified for suspension or

7 (ii) the Maryland School for the Deaf.

8 (8) **(I) [Notwithstanding] IN ADDITION TO ANY INDIVIDUALS**
9 **REHIRED IN ACCORDANCE WITH** paragraph (5) of this subsection, **AND SUBJECT TO**
10 **SUBPARAGRAPH (II) OF THIS PARAGRAPH**, each superintendent of a local school system
11 and the superintendent of the Maryland School for the Deaf may rehire a maximum of five
12 individuals who are retirees of the Teachers' Retirement System in any position at any
13 school in the superintendent's local school system or the Maryland School for the Deaf.

14 **(II) THE NUMBER OF INDIVIDUALS REHIRED UNDER**
15 **SUBPARAGRAPH (I) OF THIS PARAGRAPH FOR EACH LOCAL SCHOOL SYSTEM OR THE**
16 **MARYLAND SCHOOL FOR THE DEAF MAY NOT EXCEED A TOTAL OF FIVE RETIREES**
17 **AT ANY ONE TIME WHEN ADDED TO THE NUMBER OF INDIVIDUALS REHIRED UNDER**
18 **§ 23-407(C)(8)(I) OF THIS ARTICLE FOR THAT SAME LOCAL SCHOOL SYSTEM OR THE**
19 **MARYLAND SCHOOL FOR THE DEAF.**
