## A BILL ENTITLED

1 AN ACT concerning

2 **General Assembly and Congressional Legislative Redistricting and**  
3 **Apportionment Commission**

4 FOR the purpose of creating the General Assembly and Congressional Legislative  
5 Redistricting and Apportionment Commission; requiring the Commission to divide  
6 the State to create certain General Assembly legislative districts and congressional  
7 districts; providing for the membership, qualifications, and duties of the  
8 Commission; specifying certain requirements for the adoption of redistricting plans  
9 by the Commission; specifying that the redistricting plans meet certain standards  
10 and requirements; prohibiting the Commission from considering certain factors in  
11 adopting redistricting plans; requiring the Secretary of State to submit the  
12 Commission's final certified map and plan for General Assembly legislative districts  
13 and congressional districts to the presiding officers of the General Assembly;  
14 requiring the presiding officers to introduce separate bills for the General Assembly  
15 legislative districts and congressional districts; specifying that the maps and plans  
16 become law only on adoption by two-thirds of the members of each house of the  
17 General Assembly; providing that the Commission shall submit an alternative map  
18 and plan if the General Assembly fails to adopt a previously submitted map and plan;  
19 requiring the Legislative Auditor to establish and administer an application process  
20 for individuals seeking appointment to the Commission; prohibiting certain  
21 individuals from serving as a member of the Commission; authorizing the Legislative  
22 Auditor to disqualify certain applicants seeking membership on the Commission;  
23 requiring the Legislative Auditor to establish an Applicant Review Panel to identify  
24 and establish certain applicant pools from which certain members of the Commission  
25 are to be selected; requiring the Legislative Auditor to select at random a certain  
26 number of names from the applicant pools for membership on the Commission;  
27 requiring the Commission to elect a chair and establish certain rules and procedures;  
28 making Commission meetings and records subject to State laws governing open  
29 meetings and public records; providing that the maps and plans drawn by the

1 Commission are final and subject to review by the Court of Appeals; authorizing  
 2 certain persons to petition the Court of Appeals to challenge or to establish General  
 3 Assembly legislative districts or congressional districts under certain circumstances;  
 4 requiring the Court of Appeals to establish the boundaries of General Assembly  
 5 legislative districts or congressional districts or grant other relief under certain  
 6 circumstances; specifying that the Commission shall have certain staff and other  
 7 resources; requiring the Governor to include certain funds for the Commission in the  
 8 State budget; defining certain terms; providing for the effective date of this Act;  
 9 providing for the termination of certain provisions of this Act under certain  
 10 circumstances; submitting this amendment to the qualified voters of the State for  
 11 their adoption or rejection; and generally relating to the General Assembly and  
 12 Congressional Legislative Redistricting and Apportionment Commission.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
 27 (Three-fifths of all the members elected to each of the two Houses concurring), That it be  
 28 proposed that the Maryland Constitution read as follows:

29 **Article III – Legislative Department**

30 [5.

31 Following each decennial census of the United States and after public hearings, the  
 32 Governor shall prepare a plan setting forth the boundaries of the legislative districts for  
 33 electing of the members of the Senate and the House of Delegates.

34 The Governor shall present the plan to the President of the Senate and Speaker of  
 35 the House of Delegates who shall introduce the Governor’s plan as a joint resolution to the  
 36 General Assembly, not later than the first day of its regular session in the second year  
 37 following every census, and the Governor may call a special session for the presentation of  
 38 his plan prior to the regular session. The plan shall conform to Sections 2, 3 and 4 of this  
 39 Article. Following each decennial census the General Assembly may by joint resolution

1 adopt a plan setting forth the boundaries of the legislative districts for the election of  
2 members of the Senate and the House of Delegates, which plan shall conform to Sections  
3 2, 3 and 4 of this Article. If a plan has been adopted by the General Assembly by the 45th  
4 day after the opening of the regular session of the General Assembly in the second year  
5 following every census, the plan adopted by the General Assembly shall become law. If no  
6 plan has been adopted by the General Assembly for these purposes by the 45th day after  
7 the opening of the regular session of the General Assembly in the second year following  
8 every census, the Governor's plan presented to the General Assembly shall become law.

9 Upon petition of any registered voter, the Court of Appeals shall have original  
10 jurisdiction to review the legislative districting of the State and may grant appropriate  
11 relief, if it finds that the districting of the State is not consistent with requirements of either  
12 the Constitution of the United States of America, or the Constitution of Maryland.]

14 **(A) IN THE YEAR FOLLOWING EACH DECENNIAL CENSUS OF THE UNITED**  
15 **STATES OR WHEN REQUIRED BY THE UNITED STATES OR BY COURT ORDER, A**  
16 **GENERAL ASSEMBLY AND CONGRESSIONAL LEGISLATIVE REDISTRICTING AND**  
17 **APPORTIONMENT COMMISSION SHALL BE APPOINTED:**

18 **(1) TO DIVIDE THE STATE INTO CONSECUTIVELY NUMBERED**  
19 **GENERAL ASSEMBLY LEGISLATIVE DISTRICTS THAT CONFORM TO SECTIONS 2, 3,**  
20 **AND 4 OF THIS ARTICLE; AND**

21 **(2) TO DIVIDE THE STATE TO CREATE AS MANY CONGRESSIONAL**  
22 **DISTRICTS AS THERE ARE REPRESENTATIVES IN CONGRESS APPORTIONED TO THE**  
23 **STATE.**

24 **(B) (1) GENERAL ASSEMBLY LEGISLATIVE DISTRICTS AND**  
25 **CONGRESSIONAL LEGISLATIVE DISTRICTS SHALL BE ESTABLISHED IN ACCORDANCE**  
26 **WITH THE CONSTITUTION OF THE UNITED STATES OF AMERICA AND THIS**  
27 **CONSTITUTION.**

28 **(2) GENERAL ASSEMBLY LEGISLATIVE DISTRICTS SHALL BE AS**  
29 **NEARLY EQUAL IN POPULATION AS PRACTICABLE, BUT MAY NOT DEVIATE MORE**  
30 **THAN 2% IN POPULATION BETWEEN DISTRICTS.**

31 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
32 as follows:

33 **Article – Election Law**

34 **SUBTITLE 7A. GENERAL ASSEMBLY AND CONGRESSIONAL LEGISLATIVE**  
35 **REDISTRICTING AND APPORTIONMENT COMMISSION.**

1 **8-7A-01.**

2 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
3 INDICATED.

4 (B) "COMMISSION" MEANS THE GENERAL ASSEMBLY AND CONGRESSIONAL  
5 REDISTRICTING AND APPORTIONMENT COMMISSION.

6 (C) "DAY" MEANS A CALENDAR DAY, EXCEPT THAT IF THE FINAL DAY OF A  
7 PERIOD WITHIN WHICH AN ACT IS TO BE PERFORMED IS A SATURDAY, SUNDAY, OR  
8 HOLIDAY, THE PERIOD IS EXTENDED TO THE NEXT DAY THAT IS NOT A SATURDAY,  
9 SUNDAY, OR HOLIDAY.

10 (D) "PANEL" MEANS THE APPLICANT REVIEW PANEL.

11 (E) "QUALIFIED INDEPENDENT AUDITOR" MEANS AN AUDITOR WHO IS  
12 CURRENTLY LICENSED BY THE STATE AND HAS BEEN A PRACTICING INDEPENDENT  
13 AUDITOR FOR AT LEAST 10 YEARS BEFORE APPOINTMENT TO THE APPLICANT  
14 REVIEW PANEL.

15 **8-7A-02.**

16 IT IS THE INTENT OF THE GENERAL ASSEMBLY THAT NEITHER THE GENERAL  
17 ASSEMBLY LEGISLATIVE DISTRICTS NOR THE DISTRICTS FOR THE STATE'S  
18 REPRESENTATIVES IN THE UNITED STATES CONGRESS BE DRAWN FOR THE  
19 PURPOSE OF FAVORING OR DISCRIMINATING AGAINST AN INCUMBENT  
20 OFFICEHOLDER, A CANDIDATE, OR A POLITICAL PARTY.

21 **8-7A-03.**

22 (A) IN THE YEAR FOLLOWING THE YEAR IN WHICH THE NATIONAL CENSUS  
23 IS TAKEN UNDER THE DIRECTION OF CONGRESS AT THE BEGINNING OF EACH  
24 DECADE, THE COMMISSION SHALL ADJUST THE BOUNDARY LINES OF GENERAL  
25 ASSEMBLY LEGISLATIVE AND CONGRESSIONAL DISTRICTS IN CONFORMANCE WITH  
26 THE FOLLOWING STANDARDS AND PROCESS:

27 (1) (I) EACH MEMBER OF THE SENATE OF MARYLAND SHALL BE  
28 ELECTED FROM A SINGLE-MEMBER DISTRICT; AND

29 (II) A MEMBER OF THE HOUSE OF DELEGATES MAY BE ELECTED  
30 FROM A SINGLE-MEMBER DISTRICT OR A THREE-MEMBER DISTRICT;

31 (2) EACH MEMBER OF CONGRESS SHALL BE ELECTED FROM A

1 SINGLE-MEMBER DISTRICT;

2 (3) THE POPULATION OF EACH GENERAL ASSEMBLY LEGISLATIVE  
3 DISTRICT SHALL BE REASONABLY EQUAL IN POPULATION, BUT MAY NOT DEVIATE  
4 MORE THAN 2% IN POPULATION BETWEEN DISTRICTS;

5 (4) THE POPULATION OF ALL CONGRESSIONAL DISTRICTS SHALL BE  
6 EQUAL TO THE GREATEST EXTENT PRACTICABLE; AND

7 (5) GENERAL ASSEMBLY LEGISLATIVE DISTRICTS AND  
8 CONGRESSIONAL DISTRICTS SHALL COMPLY WITH THE REQUIREMENTS OF §  
9 8-7A-05(A) OF THIS SUBTITLE.

10 (B) (1) FOLLOWING THE CRITERIA SPECIFIED UNDER SUBSECTION (A) OF  
11 THIS SECTION, THE COMMISSION SHALL ADJUST THE BOUNDARY LINES ACCORDING  
12 TO THE CRITERIA SET FORTH AND PRIORITIZED IN THIS SUBTITLE.

13 (2) THE COMMISSION SHALL ISSUE WITH ITS FINAL MAPS A REPORT  
14 THAT:

15 (I) EXPLAINS THE BASIS ON WHICH THE COMMISSION MADE  
16 THE DECISIONS IN ACHIEVING COMPLIANCE WITH THE CRITERIA; AND

17 (II) INCLUDES DEFINITIONS OF THE TERMS AND STANDARDS  
18 USED IN DRAWING THE FINAL MAPS.

19 (C) GENERAL ASSEMBLY LEGISLATIVE DISTRICTS AND CONGRESSIONAL  
20 DISTRICTS SHALL BE NUMBERED CONSECUTIVELY COMMENCING AT THE  
21 NORTHWESTERN BOUNDARY OF THE STATE AND ENDING AT THE SOUTHEASTERN  
22 BOUNDARY.

23 (D) IN DEVELOPING THE MAPS, THE COMMISSION SHALL:

24 (1) HOLD PUBLIC HEARINGS;

25 (2) PROVIDE ACCESS TO REDISTRICTING DATA AND SOFTWARE; AND

26 (3) OTHERWISE ENSURE FULL PUBLIC PARTICIPATION IN THE  
27 REDISTRICTING PROCESS.

29 (A) THE COMMISSION SHALL:

1           **(1) CONDUCT AN OPEN AND TRANSPARENT PROCESS ENABLING FULL**  
2 **PUBLIC CONSIDERATION OF AND COMMENT ON THE DRAWING OF DISTRICT LINES;**

3           **(2) DRAW GENERAL ASSEMBLY LEGISLATIVE DISTRICTS AND**  
4 **CONGRESSIONAL DISTRICT LINES ACCORDING TO THE REDISTRICTING CRITERIA**  
5 **SPECIFIED IN THIS SUBTITLE; AND**

6           **(3) CONDUCT ITS BUSINESS WITH INTEGRITY AND FAIRNESS.**

7           **(B) (1) THE SELECTION PROCESS FOR THE COMMISSION IS DESIGNED TO**  
8 **PRODUCE A COMMISSION THAT IS INDEPENDENT FROM LEGISLATIVE INFLUENCE**  
9 **AND REASONABLY REPRESENTATIVE OF THE STATE'S DIVERSITY.**

10           **(2) THE COMMISSION SHALL CONSIST OF THE FOLLOWING NINE**  
11 **MEMBERS:**

12           **(I) THREE MEMBERS REGISTERED WITH THE POLITICAL PARTY**  
13 **THAT HAS THE HIGHEST NUMBER OF REGISTERED VOTERS IN THE STATE;**

14           **(II) THREE MEMBERS REGISTERED WITH THE POLITICAL PARTY**  
15 **THAT HAS THE SECOND-HIGHEST NUMBER OF REGISTERED VOTERS IN THE STATE;**  
16 **AND**

17           **(III) THREE MEMBERS NOT REGISTERED WITH EITHER OF THE**  
18 **TWO POLITICAL PARTIES THAT HAVE THE HIGHEST AND SECOND-HIGHEST NUMBER**  
19 **OF REGISTERED VOTERS IN THE STATE.**

20           **(3) EACH MEMBER OF THE COMMISSION:**

21           **(I) SHALL BE A VOTER WHO, FOR 5 OR MORE YEARS**  
22 **IMMEDIATELY PRECEDING THE DATE OF THE INDIVIDUAL'S APPOINTMENT, HAS**  
23 **BEEN REGISTERED CONTINUOUSLY IN THE STATE WITH THE SAME POLITICAL PARTY**  
24 **OR HAS BEEN UNAFFILIATED WITH A POLITICAL PARTY AND HAS NOT CHANGED**  
25 **POLITICAL PARTY AFFILIATION;**

26           **(II) 1. MAY NOT HAVE BEEN A CANDIDATE FOR ELECTION TO**  
27 **OR SERVED AS A MEMBER OF THE GENERAL ASSEMBLY OR OF THE UNITED STATES**  
28 **CONGRESS FROM THIS STATE DURING THE 5 YEARS IMMEDIATELY PRECEDING THE**  
29 **DATE OF THE INDIVIDUAL'S APPOINTMENT, OR AN IMMEDIATE FAMILY MEMBER**  
30 **ESTABLISHED THROUGH BLOOD OR LEGAL RELATION OF SUCH CANDIDATE OR**  
31 **MEMBER;**

1                                   **2.     MAY NOT BE A REGULATED LOBBYIST IN THIS STATE;**  
2 **AND**

3                                   **3.     MAY NOT BE OR HAVE SERVED AS STAFF OR A**  
4 **CONSULTANT TO A PERSON UNDER A CONTRACT WITH, OR ANY PERSON WITH AN**  
5 **IMMEDIATE FAMILY RELATIONSHIP THROUGH BLOOD OR LEGAL RELATION TO, THE**  
6 **GOVERNOR, A MEMBER OF THE GENERAL ASSEMBLY, OR A MEMBER OF CONGRESS**  
7 **FROM THIS STATE.**

8                                   **(4)    THE TERM OF OFFICE OF EACH MEMBER OF THE COMMISSION**  
9 **EXPIRES ON THE APPOINTMENT OF THE FIRST MEMBER OF THE SUCCEEDING**  
10 **COMMISSION.**

11                                  **(5)    (I)    SEVEN MEMBERS OF THE COMMISSION SHALL CONSTITUTE**  
12 **A QUORUM.**

13                                  **(II)   SIX OR MORE AFFIRMATIVE VOTES OF THE COMMISSION**  
14 **SHALL BE REQUIRED FOR ANY OFFICIAL ACTION, INCLUDING ANY FINAL PROPOSED**  
15 **MAPS AND PLANS FOR GENERAL ASSEMBLY LEGISLATIVE DISTRICTS OR**  
16 **CONGRESSIONAL DISTRICTS ADOPTED BY THE COMMISSION.**

17                                  **(6)    EACH MEMBER OF THE COMMISSION SHALL:**

18                                       **(I)    APPLY THE PROVISIONS OF THIS SUBTITLE IN A MANNER**  
19 **THAT IS IMPARTIAL AND THAT REINFORCES PUBLIC CONFIDENCE IN THE INTEGRITY**  
20 **OF THE REDISTRICTING PROCESS; AND**

21                                       **(II)   BE INELIGIBLE FOR A PERIOD OF 5 YEARS BEGINNING FROM**  
22 **THE DATE OF APPOINTMENT:**

23   **1.     TO HOLD APPOINTIVE FEDERAL, STATE, OR LOCAL**  
24 **PUBLIC OFFICE;**

25   **2.     TO SERVE AS PAID STAFF FOR THE GENERAL**  
26 **ASSEMBLY OR ANY INDIVIDUAL LEGISLATOR; OR**

27   **3.     TO REGISTER AS A FEDERAL, STATE, COUNTY, OR**  
28 **MUNICIPAL LOBBYIST IN THE STATE.**

30                                   **(A)    (1)    EACH GENERAL ASSEMBLY LEGISLATIVE DISTRICT SHALL**  
31 **COMPLY WITH ARTICLE III, §§ 2, 3, AND 4 OF THE MARYLAND CONSTITUTION.**

1           **(2) EACH CONGRESSIONAL DISTRICT SHALL:**

2                   **(I) COMPLY WITH THE UNITED STATES CONSTITUTION;**

3                   **(II) COMPLY WITH THE FEDERAL VOTING RIGHTS ACT;**

4                   **(III) BE EQUAL IN POPULATION, EXCEPT WHERE DEVIATION IS**  
5 **REQUIRED TO COMPLY WITH THE FEDERAL VOTING RIGHTS ACT (42 U.S.C. SEC.**  
6 **1971 AND FOLLOWING) OR IS ALLOWABLE BY LAW;**

7                   **(IV) WITHOUT VIOLATING THE REQUIREMENTS OF THIS**  
8 **SECTION, RESPECT THE GEOGRAPHIC INTEGRITY OF ANY MUNICIPAL CORPORATION**  
9 **OR COUNTY, TO THE EXTENT POSSIBLE;**

3 (A) THE COMMISSION:

4 (1) HAS THE SOLE LEGAL STANDING TO DEFEND ANY ACTION  
5 REGARDING A CERTIFIED FINAL MAP AND PLAN; AND

6 (2) SHALL INFORM THE GENERAL ASSEMBLY IF THE COMMISSION  
7 DETERMINES THAT FUNDS OR OTHER RESOURCES PROVIDED FOR THE OPERATION  
8 OF THE COMMISSION ARE NOT ADEQUATE.

9 (B) THE GENERAL ASSEMBLY SHALL PROVIDE ADEQUATE FUNDING TO  
10 DEFEND ANY ACTION REGARDING A CERTIFIED FINAL MAP AND PLAN.

15 (A) THE SECRETARY OF STATE SHALL FORWARD CERTIFIED FINAL MAPS  
16 AND PLANS SUBMITTED BY THE COMMISSION TO THE PRESIDING OFFICERS OF THE  
17 GENERAL ASSEMBLY FOR THE INTRODUCTION BY THE PRESIDING OFFICERS OF A  
18 SEPARATE BILL CONTAINING:

29 A GENERAL ASSEMBLY LEGISLATIVE DISTRICT OR CONGRESSIONAL DISTRICT MAP  
30 AND PLAN AS PROVIDED IN THIS SUBSECTION.

1           **(2) (I) 1. TO ADOPT A MAP AND PLAN, EACH HOUSE OF THE**  
2 **GENERAL ASSEMBLY SHALL PASS THE BILL BY A VOTE OF THREE-FIFTHS OF THE**  
3 **MEMBERS OF THAT HOUSE.**

4                           **2. ON PASSAGE BY THE GENERAL ASSEMBLY, THE BILL**  
5 **SHALL BE PRESENTED TO THE GOVERNOR FOR SIGNATURE OR VETO.**

6                           **(II) 1. IF THE GOVERNOR VETOES THE BILL AND THE**

5 **APPROPRIATION IN THE STATE BUDGET, AND THE APPROPRIATION SHALL BE**  
6 **AVAILABLE DURING THE ENTIRE 3-YEAR PERIOD.**

7           **(2) THE APPROPRIATION SHALL BE EQUAL TO THE GREATER OF**  
8 **\$3,000,000, OR THE AMOUNT EXPENDED UNDER THIS SUBTITLE IN THE**  
9 **IMMEDIATELY PRECEDING REDISTRICTING PROCESS, AS EACH AMOUNT IS**  
10 **ADJUSTED BY THE CUMULATIVE CHANGE IN THE MARYLAND CONSUMER PRICE**  
11 **INDEX OR ITS SUCCESSOR SINCE THE DATE OF THE IMMEDIATELY PRECEDING**  
12 **APPROPRIATION.**

13           **(D) THE COMMISSION, WITH FISCAL OVERSIGHT FROM THE DEPARTMENT**  
14 **OF BUDGET AND MANAGEMENT, SHALL HAVE PROCUREMENT AND CONTRACTING**  
15 **AUTHORITY AND MAY HIRE STAFF AND CONSULTANTS, INCLUDING LEGAL**  
16 **REPRESENTATION.**

17           SECTION 3. AND BE IT FURTHER ENACTED, That the General Assembly  
18 determines that the amendment to the Maryland Constitution proposed by this Act affects  
19 multiple jurisdictions and that the provisions of Article XIV, § 1 of the Maryland  
20 Constitution concerning local approval of constitutional amendments do not apply.

21           SECTION 4. AND BE IT FURTHER ENACTED, That the amendment to the  
22 Maryland Constitution proposed by Section 1 of this Act shall be submitted to the qualified  
23 voters of the State at the next general election to be held in November 2016 for their  
24 adoption or rejection pursuant to Article XIV of the Maryland Constitution. At that general  
25 election, the vote on this proposed amendment to the Constitution shall be by ballot, and  
26 upon each ballot there shall be printed the words "For the Constitutional Amendment" and  
27 "Against the Constitutional Amendment," as now provided by law. Immediately after the  
28 election, all returns shall be made to the Governor of the vote for and against the proposed  
29 amendment, as directed by Article XIV of the Maryland Constitution, and further  
30 proceedings had in accordance with Article XIV.

31           SECTION 5. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall  
32 take effect on the taking effect of Section 1 of this Act. If Section 1 of this Act does not take  
33 effect, Section 2 of this Act shall be abrogated and of no further force and effect.

34           SECTION 6. AND BE IT FURTHER ENACTED, That except as provided in Sections  
35 4 and 5 of this Act, this Act shall take effect June 1, 2016.
