5 FOR the purpose of requiring the State Department of Education, in consultation with the 6 Department of Health and Mental Hygiene, county boards of education, and certain 7 other stakeholders, to develop and implement a certain reporting system to 8 determine the effectiveness of community-partnered school behavioral health 9 services programs; requiring a certain reporting system to use certain measures 10 designed for a certain purpose; requiring the Department to submit certain reports 11 to the Governor and the General Assembly on or before certain dates; defining 12 certain terms; and generally relating to community-partnered school behavioral 13 health services programs.
