7 (vi) After certifying that the landowner or child of the landowner has

9 Foundation shall issue a preliminary release which shall:

10 1. Become final when the Foundation receives and certifies a  
11 nontransferable building permit in the name of the landowner or child of the landowner for  
12 construction of a dwelling house; [or]

13 2. Become void upon the death of the person for whose  
14 benefit the release was intended if the Foundation has not yet received a building permit  
15 as provided in this subparagraph; or

16 3. Unless extended by a majority vote of the Foundation  
17 Board of Trustees, become void if a nontransferable building permit in the name of the  
18 landowner or child of the landowner is not received by the Foundation within 3 years of the  
19 date of recordation of the preliminary release.
