A BILL ENTITLED

1 AN ACT concerning

2 **Carroll County – Alcoholic Beverages Licenses – Beginning Hour of Sale**

3 FOR the purpose of altering the beginning hour of sale for certain alcoholic beverages
4 licenses issued in Carroll County; and generally relating to alcoholic beverages in
5 Carroll County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

21 16–102.

22 This title applies only in Carroll County.

1 (a) A holder of a Class A beer and wine license may sell or provide beer and wine
2 on Monday through Sunday from 8 a.m. to 11 p.m.

3 (b) (1) A holder of a 6-day or 7-day Class B beer and wine license may sell or
4 provide beer and wine for on-premises consumption[:

5 (i)] on Monday through Saturday from 8 a.m. to 1 a.m. the following
6 day[; and

7 (ii) on Sunday from 11 a.m. to 1 a.m. the following day].

8 (2) A holder of a 7-day Class B beer and wine license may sell beer and
9 wine for **ON- OR** off-premises consumption[:

10 (i)] on Monday through [Saturday] **SUNDAY** from 8 a.m. to 11 p.m.
11 the following day[; and

12 (ii) on Sunday from 11 a.m. to 11 p.m.].

13 (c) A holder of a Class C beer and wine license may sell or provide beer and wine
14 on Monday through Saturday from 8 a.m. to 1 a.m. the following day.

15 (d) (1) A holder of a 6-day or 7-day Class D beer and wine license may sell or
16 provide beer and wine on Monday through Saturday from 6 a.m. to midnight.

17 (2) A holder of a 7-day Class D beer and wine license may sell or provide
18 beer and wine on Sunday from [11 a.m.] **8 A.M.** to 11 p.m.

19 16-2005.

20 (a) A holder of a Class A beer, wine, and liquor license may sell or provide beer,
21 wine, and liquor on Monday through Sunday from 8 a.m. to 11 p.m.

22 (b) A holder of a Class B beer, wine, and liquor license may sell or provide beer,
23 wine, and liquor[:

24 (1)] on Monday through [Saturday] **SUNDAY** from 8 a.m. to 1 a.m. the
25 following day[; and

26 (2) on Sunday from 11 a.m. to 1 a.m. the following day].

27 (c) A holder of a Class C beer, wine, and liquor license may sell or provide beer,
28 wine, and liquor[:

29 (1)] on Monday through [Saturday] **SUNDAY** from 8 a.m. to 1 a.m. the
30 following day[; and

1 (2) on Sunday from 11 a.m. to 1 a.m. the following day].

2 (d) Reserved.

3 (e) A holder of a Class H beer, wine, and liquor license may sell or provide beer,
4 wine, and liquor[:

5 (1)] on Monday through [Saturday] **SUNDAY** from 8 a.m. to 1 a.m. the
6 following day[; and

7 (2) on Sunday from 11 a.m. to 1 a.m. the following day].

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
9 1, 2016.
