## A BILL ENTITLED

1 AN ACT concerning

2 **Real Estate Brokers – Agency Relationships in Residential Real Estate**  
3 **Transactions – Disclosure and Consent Requirements**

4 FOR the purpose of altering the requirements for a certain disclosure that a licensee of the  
5 State Real Estate Commission must make under certain circumstances; establishing  
6 a certain exception to a certain disclosure requirement; establishing a certain  
7 exception to the time when a certain disclosure must occur; requiring the  
8 Commission to prepare and provide a certain required notice; requiring a subagent  
9 to make a certain required disclosure under certain circumstances; requiring a  
10 seller's agent to make a certain required disclosure under certain circumstances;  
11 requiring a buyer's agent to make a certain required disclosure under certain  
12 circumstances; altering the contents of a certain required disclosure; altering a  
13 certain exception to a certain prohibition on certain licensees acting as a dual agent;  
14 altering a certain prohibition on an intra-company agent disclosing certain  
15 confidential information; requiring a certain intra-company agent to provide certain  
16 services to a client under certain circumstances; prohibiting a dual agent from also  
17 acting as an intra-company agent under certain circumstances; prohibiting an  
18 intra-company agent from also acting as a dual agent under certain circumstances;  
19 altering the contents of a certain consent for dual agency; altering who may  
20 withdraw from representing a certain client under certain circumstances and the  
21 effect of the withdrawal; requiring certain licensees to use a certain standard  
22 disclosure form under certain circumstances; requiring a certain licensee or branch  
23 office manager to use a certain standard consent form under certain circumstances;  
24 repealing certain provisions of law regarding a presumed buyer's or lessee's agency  
25 relationship; altering certain definitions; repealing a certain definition; making  
26 stylistic and conforming changes; and generally relating to agency relationships of  
27 licensees of the State Real Estate Commission in residential real estate transactions.

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
9 That the Laws of Maryland read as follows:

10 **Article – Business Occupations and Professions**

11 17–528.

12 (a) In this Part III of this subtitle the following words have the meanings  
13 indicated.

14 (b) “Agency relationship” means each relationship in which a licensee acts for or  
15 represents another person with the person’s authority in a residential real estate  
16 transaction.

17 (c) “Broker” means a licensed real estate broker, including a corporation, limited  
18 liability company, partnership, or sole proprietorship through which a licensed real estate  
19 broker provides real estate brokerage services under § 17–321 of this title.

20 (d) “Brokerage agreement” means a written agreement between a broker and a  
21 client to provide real estate brokerage services under a brokerage relationship.

22 (e) “Brokerage relationship” means an agency relationship under a brokerage  
23 agreement between a client and a broker who has been engaged by the client to provide  
24 real estate brokerage services in a residential real estate transaction.

25 **(F) “BUYER’S AGENT” MEANS A LICENSED REAL ESTATE BROKER,**  
26 **LICENSED ASSOCIATE REAL ESTATE BROKER, OR LICENSED REAL ESTATE**  
27 **SALESPERSON WHO, IN ACCORDANCE WITH A WRITTEN BROKERAGE AGREEMENT,**  
28 **REPRESENTS A PROSPECTIVE BUYER OR LESSEE IN THE ACQUISITION OF REAL**  
29 **ESTATE FOR SALE OR FOR LEASE.**

30 **[(f)] (G)** “Client” means a person who has entered into a brokerage agreement  
31 with a broker under a brokerage relationship.

32 **[(g)] (H)** (1) “Common source information company” means any person that  
33 is a source, compiler, or supplier of information regarding residential real estate for sale or  
34 lease or other data.

1                   (2)    “Common source information company” includes a multiple listing  
2 service.

3           **[(h)] (I)**    “Confidential information” includes information that:

4                   (1)    the seller or lessor will accept a price or rent less than the price or rent  
5 as set forth in the brokerage agreement or will accept terms other than those contained in  
6 the brokerage agreement;

7                   (2)    the buyer or lessee is willing to pay a price or rent higher than the price  
8 or rent the buyer or lessee offered or will accept terms other than those contained in the  
9 offer of the buyer or lessee;

10                  (3)    discloses the motivation of a buyer, lessee, seller, or lessor or the need  
11 or urgency of a seller to sell, a buyer to buy, a lessee to lease, or a lessor to lease;

12                  (4)    discloses any facts that led the seller to sell, the buyer to buy, the lessee  
13 to lease, or the lessor to lease; or

14                  (5)    relates to the negotiating strategy of a client.

15           **(J)    “DUAL AGENT” MEANS A LICENSED REAL ESTATE BROKER WHO ACTS AS,  
16 OR A BRANCH OFFICE MANAGER DESCRIBED IN § 17-518(D) OF THIS SUBTITLE WHO  
17 HAS BEEN DESIGNATED BY THE LICENSED REAL ESTATE BROKER TO ACT AS, AN  
18 AGENT FOR BOTH THE SELLER AND THE BUYER OR THE LESSOR AND THE LESSEE IN  
19 THE SAME REAL ESTATE TRANSACTION.**

20           **(K)    “INTRA-COMPANY AGENT” MEANS A LICENSED ASSOCIATE REAL  
21 ESTATE BROKER OR LICENSED REAL ESTATE SALESPERSON WHO HAS BEEN  
22 DESIGNATED BY A DUAL AGENT TO ACT ON BEHALF OF A SELLER OR LESSOR OR  
23 BUYER OR LESSEE IN THE PURCHASE, SALE, OR LEASE OF REAL ESTATE.**

24           **[(i)] (L)**    “Ministerial act” means an act that:

25                   (1)    a licensee performs on behalf of a client before and after the execution  
26 of a contract of sale or lease;

27                   (2)    assists another person to complete or fulfill a contract of sale or lease  
28 with the client of the licensee; and

29                   (3)    does not involve discretion or the exercise of the licensee’s own  
30 judgment.

31           **(M)    “SELLER’S AGENT” MEANS A LICENSED REAL ESTATE BROKER WHO, IN  
32 ACCORDANCE WITH A WRITTEN BROKERAGE AGREEMENT, ACTS AS THE LISTING**

1 **BROKER FOR REAL ESTATE, OR A LICENSED ASSOCIATE REAL ESTATE BROKER OR**  
 2 **LICENSED REAL ESTATE SALESPERSON WHO IS AFFILIATED WITH THE LISTING**  
 3 **BROKER.**

4 **[(j)] (N)** “Subagent” [includes a cooperating agent who acts on behalf of a client  
 5 of another broker] **MEANS A LICENSED REAL ESTATE BROKER, LICENSED ASSOCIATE**  
 6 **REAL ESTATE BROKER, OR LICENSED REAL ESTATE SALESPERSON WHO:**

7 **(1) IS NOT AFFILIATED WITH OR ACTING AS THE LISTING REAL**  
 8 **ESTATE BROKER FOR A PROPERTY;**

9 **(2) IS NOT A BUYER’S AGENT;**

10 **(3) HAS AN AGENCY RELATIONSHIP WITH THE SELLER OR LESSOR;**  
 11 **AND**

12 **(4) ASSISTS A PROSPECTIVE BUYER OR LESSEE IN THE ACQUISITION**  
 13 **OF REAL ESTATE FOR SALE OR FOR LEASE IN A NONAGENCY CAPACITY.**

14 **[(k)] (O)** “Timely” means a reasonable time under the particular facts and  
 15 circumstances.

16 17–530.

17 (a) **[(1)** In this section the following words have the meanings indicated.

18 (2) “Buyer’s agent” means a licensed real estate broker, licensed associate  
 19 real estate broker, or licensed real estate salesperson who represents a prospective buyer  
 20 or lessee in the acquisition of real estate for sale or for lease.

21 (3) “Cooperating agent” means a licensed real estate broker, licensed  
 22 associate real estate broker, or licensed real estate salesperson who:

23 (i) is not affiliated with or is not acting as the listing real estate  
 24 broker for a property; and

25 (ii) assists a prospective buyer or lessee as a subagent of the listing  
 26 real estate broker, in the acquisition of real estate for sale or for lease.

27 (4) “Intra–company agent” means a licensed associate real estate broker or  
 28 licensed real estate salesperson who has been designated by the real estate broker who the  
 29 associate real estate broker or licensed real estate salesperson is affiliated with to act as a  
 30 dual agent on behalf of a seller or lessor or buyer or lessee in the purchase, sale, or lease of  
 31 real estate that is listed with the real estate broker.

1           (5) “Dual agent” means a licensed real estate broker, licensed associate real  
2 estate broker, or licensed real estate salesperson who acts as an agent for both the seller  
3 and the buyer or the lessor and the lessee in the same real estate transaction.

4           (6) “Seller’s agent” means a licensed real estate broker, licensed associate  
5 real estate broker, or licensed real estate salesperson who:

6                   (i) is affiliated with or acts as the listing broker for real estate; and

7                   (ii) assists a prospective buyer or lessee in the acquisition of real  
8 estate for sale or for lease.

9           **(b)] (1) [A] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**  
10 **SUBSECTION, A licensee who participates in a residential real estate transaction as a**  
11 **seller’s agent, buyer’s agent, or [as a cooperating agent] A SUBAGENT shall disclose in**  
12 **writing that the licensee represents the seller or lessor or the buyer or lessee AS PROVIDED**  
13 **IN THIS SECTION.**

14           **(2) THE DISCLOSURE REQUIRED UNDER THIS SECTION DOES NOT**  
15 **APPLY TO A SELLER, LESSOR, BUYER, OR LESSEE WITH WHOM A BROKER HAS**  
16 **ENTERED INTO A WRITTEN BROKERAGE AGREEMENT.**

17           **[(2)] (B) (1) [The] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF**  
18 **THIS SUBSECTION, THE disclosure shall occur not later than the first scheduled**  
19 **face-to-face contact with the seller or lessor or the buyer or lessee.**

20           **(2) (I) IF A LICENSEE IS HOLDING A PROPERTY OPEN TO THE**  
21 **PUBLIC, THE LICENSEE COMPLIES WITH THE DISCLOSURE REQUIREMENTS OF THIS**  
22 **SECTION IF THE LICENSEE DISPLAYS, IN A CONSPICUOUS MANNER, A NOTICE TO**  
23 **PROSPECTIVE BUYERS OR LESSEES THAT THE LICENSEE PRESENT ON THE**  
24 **PROPERTY REPRESENTS THE SELLER OR LESSOR.**

25           **(II) THE COMMISSION SHALL PREPARE AND PROVIDE THE**  
26 **NOTICE REQUIRED UNDER THIS PARAGRAPH.**

27           **[(3)] (C) [(i)]** In any residential real estate transaction involving a  
28 **[cooperating agent as defined in this section, it shall be the obligation of the cooperating**  
29 **agent to make the written disclosure] SUBAGENT, THE SUBAGENT SHALL DISCLOSE IN**  
30 **WRITING to the buyer or lessee AS required under this section THAT THE SUBAGENT**  
31 **REPRESENTS THE SELLER OR LESSOR.**

32           **[(ii)] (D)** In any residential real estate transaction that does not  
33 involve a **[cooperating agent as defined in this section, it shall be the obligation of the**  
34 **seller’s agent, as defined in this section, to] SUBAGENT OR BUYER’S AGENT, THE**

1 **SELLER'S AGENT SHALL** make the written disclosure to the buyer or lessee required under  
2 this section **THAT THE SELLER'S AGENT REPRESENTS THE SELLER OR LESSOR.**

3 ~~[(4)]~~ **(E)** In any residential real estate transaction [involving a buyer's  
4 agent, it shall be the obligation of the buyer's agent to] **THAT DOES NOT INVOLVE A**  
5 **SELLER'S AGENT, THE BUYER'S AGENT SHALL** make the written disclosure to the seller  
6 or lessor [or the agent of the seller or lessor as] required under this section **THAT THE**  
7 **BUYER'S AGENT REPRESENTS THE BUYER OR LESSEE.**

8 ~~[(5)]~~ **(F)** The written disclosure shall explain:

9 ~~[(i)]~~ **(1)** the differences between a seller's agent, buyer's agent,  
10 [cooperating agent] **SUBAGENT**, dual agent, and intra-company agent;

11 ~~[(ii)]~~ **(2)** the duties of a licensee to exercise reasonable care and  
12 diligence and maintain confidentiality;

13 ~~[(iii)]~~ that a licensee who assists a buyer or lessee in locating  
14 residential real estate for purchase or lease and is neither affiliated with nor acting as the  
15 listing real estate broker for any real estate shown or located, is presumed to be acting as  
16 a buyer's agent on behalf of the prospective buyer or lessee, unless either the licensee or  
17 the prospective buyer or lessee expressly declines to have the licensee act as a buyer's agent;

18 ~~[(iv)]~~ **(3)** that regardless of whom a licensee represents in a real  
19 estate transaction, the licensee has a duty to treat each party fairly **AND HONESTLY**,  
20 promptly present each written offer and counteroffer, respond truthfully to each question,  
21 disclose all material facts that are known or should be known relating to a property, and  
22 offer each property without discrimination;

23 ~~[(v)]~~ **(4)** that a licensee is qualified to advise only on real estate  
24 matters and that legal or tax advice should be obtained from a licensed attorney or  
25 accountant;

26 ~~[(vi)]~~ **(5)** the need for an agreement with a seller's agent, buyer's  
27 agent, or dual agent to be in writing and to include the duties and obligations of the agent,  
28 how and by whom the agent will be compensated, and any fee-sharing arrangements with  
29 other agents;

30 ~~[(vii)]~~ **(6)** the duty of a buyer's agent to assist in the:

31 ~~[1.]~~ **(I)** evaluation of a property, including the provision of  
32 a market analysis of the property; and

33 ~~[2.]~~ **(II)** preparation of an offer on a property and to  
34 negotiate in the best interests of the buyer;

1 [(viii)] (7) the possibility that a dual agency may arise in a real estate  
2 transaction and the options that would become available to the buyer and seller or lessee  
3 and lessor; and

4 [(ix)] (8) that any complaints concerning a licensee may be filed  
5 with the [State Real Estate] Commission.

7 [(c)] (A) Except as otherwise provided in subsection [(d)] (B) of this section, a  
8 licensed real estate broker, licensed associate real estate broker, or licensed real estate  
9 salesperson may not act as a dual agent in this State.

10 [(d)] (B) (1) (i) If a licensed real estate broker [or a designee of the real estate  
11 broker] obtains the written informed consent of all parties to a real estate transaction, the  
12 real estate broker, **OR A BRANCH OFFICE MANAGER DESCRIBED IN § 17-518(D) OF**  
13 **THIS SUBTITLE WHO HAS BEEN DESIGNATED BY THE LICENSED REAL ESTATE**  
14 **BROKER,** may act as a dual agent [in the transaction] **FOR BOTH THE SELLER AND THE**  
15 **BUYER OR THE LESSOR AND THE LESSEE IN THE SAME REAL ESTATE TRANSACTION.**

16 (ii) [When acting as a] **THE** dual agent in a real estate transaction[,  
17 a real estate broker or a designee of the real estate broker] shall assign a licensed associate  
18 real estate broker or licensed real estate salesperson affiliated with the real estate broker  
19 to act as the intra-company agent on behalf of the seller or lessor and another licensed  
20 associate real estate broker or licensed real estate salesperson affiliated with the real estate  
21 broker to act as the intra-company agent on behalf of the buyer or lessee.

22 (iii) 1. Except as otherwise required by this title and except to the  
23 [intra-company agent's real estate broker or a designee of the real estate broker] **DUAL**  
24 **AGENT,** an intra-company agent may not disclose **CONFIDENTIAL** information [that a  
25 seller or buyer in a real estate transaction requests to remain confidential].

26 2. Except as otherwise required by this title, [the real estate  
27 broker or the designee of the real estate broker acting as] the dual agent may not disclose  
28 confidential information to the buyer or seller or the buyer's or seller's intra-company agent  
29 in the same real estate transaction.

30 (iv) If a real estate broker offers any financial bonuses to licensees  
31 affiliated with the broker for the sale or lease of real property listed with the real estate  
32 broker, the real estate broker shall provide to each party to a real estate transaction a  
33 statement that discloses that financial bonuses are offered.

34 (v) An intra-company agent representing the seller or buyer [may]  
35 **SHALL** provide the same services to the client as an [exclusive] agent for the seller or buyer

1 **WOULD PROVIDE IN A REAL ESTATE TRANSACTION THAT DOES NOT INVOLVE DUAL**  
2 **AGENCY**, including advising the client as to price and negotiation strategy, provided that  
3 the intra-company agent has made the appropriate disclosures to the client and the client  
4 has consented, as required by this section, to dual agency representation.

5 (vi) The provisions of the services specified in this subsection may not  
6 be construed to be a breach of duty of the licensee, provided that the licensee has complied  
7 with the duties specified in § 17-522 of this subtitle.

8 **(VII) 1. A DUAL AGENT MAY NOT ALSO ACT AS AN**  
9 **INTRA-COMPANY AGENT IN THE SAME REAL ESTATE TRANSACTION.**

10 **2. AN INTRA-COMPANY AGENT MAY NOT ALSO ACT AS A**  
11 **DUAL AGENT IN THE SAME REAL ESTATE TRANSACTION.**

12 (2) The written consent **FOR DUAL AGENCY** shall identify [each property  
13 for which the real estate broker will serve as a dual agent] **THE PROPERTY AND THE**  
14 **IDENTITY OF THE BUYER WHEN THE REAL ESTATE BROKER OR BRANCH OFFICE**  
15 **MANAGER IS SERVING AS A DUAL AGENT AND THE BUYER AND SELLER OR LESSEE**  
16 **AND LESSOR ENTER INTO A WRITTEN CONTRACT FOR SALE OR FOR A LEASE,**  
17 **RESPECTIVELY.**

18 **[(3)] (C)** The written consent **FOR DUAL AGENCY** shall include a  
19 statement that:

20 **[(i)] (1)** the real estate broker receives compensation on the sale of  
21 a property listed only by the broker;

22 **[(ii)] (2)** as a dual agent the real estate broker represents both the  
23 seller and the buyer and there may be a conflict of interest because the interests of the  
24 seller and the buyer may be different or adverse;

25 **[(iii)] (3)** as a dual agent the real estate broker does not owe  
26 undivided loyalty to either the seller or the buyer;

27 **[(iv)] (4)** except as otherwise required by this title, a dual agent  
28 may not disclose **CONFIDENTIAL** information [that a seller or buyer in a real estate  
29 transaction requests to remain confidential] to the buyer or seller in the same real estate  
30 transaction;

31 **[(v)] (5)** unless authorized by the seller, a dual agent may not tell  
32 a buyer that the seller will accept a price lower than the listing price or accept terms other  
33 than those contained in the listing agreement [or suggest that the seller accept a lower  
34 price in the presence of the buyer];



1            [(vi)] (6) unless authorized by the buyer, a dual agent may not tell  
2 a seller that the buyer is willing to pay a price higher than the price the buyer offered or  
3 accept terms other than those contained in the offer of the buyer [or suggest that the buyer  
4 pay a higher price in the presence of the seller];

5            [(vii)] (7) a dual agent may not disclose the motivation of a buyer or  
6 seller or the need or urgency of a seller to sell or a buyer to buy;

7            [(viii)] (8) except as otherwise required by this title, if the  
8 information is confidential, a dual agent may not disclose any facts that lead the seller to  
9 sell;

10           [(ix)] (9) the buyer or seller does not have to consent to the dual  
11 agency;

12           [(x)] (10) the buyer or seller has voluntarily consented to the dual  
13 agency; and

14           [(xi)] (11) the terms of the dual agency are understood by the buyer  
15 or seller.

16           [(4) (i)] (D) (1) A cause of action may not arise against a licensee  
17 for disclosure of the dual agency relationship as provided by this section.

18           [(ii)] (2) A dual agent does not terminate any brokerage  
19 relationship by making any required disclosure of dual agency.

20           [(5) (i)] (E) (1) In any residential real estate transaction, a  
21 [licensee] LICENSED REAL ESTATE BROKER may withdraw from representing a client  
22 who refuses to consent to a disclosed dual agency and to terminate the brokerage  
23 relationship with the client.

24           [(ii)] (2) The withdrawal may not prejudice the ability of the  
25 [licensee] LICENSED REAL ESTATE BROKER to continue to represent the other client in  
26 the transaction, nor to limit the [licensee] LICENSED REAL ESTATE BROKER from  
27 representing the client who refused the dual agency in other transactions not involving  
28 dual agency.

30           [(e)] (A) (1) [The State Real Estate Commission shall require a] A licensed  
31 real estate broker, licensed associate real estate broker, or licensed real estate salesperson  
32 who participates in a residential real estate transaction [to] SHALL utilize a standard  
33 disclosure form in each real estate transaction that includes the information specified in  
34 [subsection (b)(5) of this section] § 17-530(F) OF THIS SUBTITLE.

1           (2)    [The State Real Estate Commission shall require a] **A** licensed real  
2 estate broker **OR BRANCH OFFICE MANAGER** who acts as a dual agent and a licensed real  
3 estate associate broker or licensed real estate salesperson who acts as an intra-company  
4 agent in a real estate transaction [to] **SHALL** utilize a standard consent form that includes  
5 the information specified in [subsection (d)(3) of this section] **§ 17-530.1(C) OF THIS**  
6 **SUBTITLE**.

7           [(f)] **(B)**    (1)    The [State Real Estate] Commission shall prepare and provide  
8 [a copy of]:

9                   (i)    the standard disclosure form required under subsection [(b)]  
10 **(A)(1)** of this section to each licensee in this State; and

11                   (ii)   the standard consent form **FOR DUAL AGENCY** required under  
12 subsection [(d)] **(A)(2)** of this section to each licensee in this State.

13           (2)    The **STANDARD** disclosure form and the **STANDARD** consent form **FOR**  
14 **DUAL AGENCY** shall be:

15                   (i)    written in a clear and coherent manner using words with  
16 common and everyday meanings;

17                   (ii)   appropriately divided and captioned by their various sections;  
18 and

19                   (iii)   printed in at least 10 point type.

21           (a)    A licensee who assists a prospective buyer or lessee in locating residential real  
22 estate for purchase or lease and is neither affiliated with nor acting as the listing real estate  
23 broker for any real estate shown or located, is presumed to be acting as the buyer's or  
24 lessee's agent representing the buyer or lessee unless either the licensee or the buyer or  
25 lessee expressly declines to have the licensee act as a buyer's or lessee's agent.

26           (b)    A presumed buyer's or lessee's agency relationship shall be terminated if:

27                   (1)    either the buyer, lessee, or licensee expressly states a wish to terminate  
28 the presumed agency relationship; or

29                   (2)    the licensee and either the buyer or the lessee enter into a brokerage  
30 agreement.

31           (c)    The buyer or lessee does not have an obligation to continue to work with the  
32 licensee or to pay the licensee while acting under a presumed agency relationship.

1 (d) A licensee who is acting as a presumed buyer's or lessee's agent may show and  
2 assist the buyer or lessee only on real estate that is not listed by the broker of that licensee.

3 (e) Before the licensee may show or assist the buyer or lessee in locating real  
4 estate listed for sale by the broker with whom the licensee is affiliated, the licensee shall  
5 disclose to the prospective buyer or lessee that the licensee represents the seller or lessor  
6 for that real estate as provided in § 17-530(b) of this subtitle.

7 (f) A licensee may represent the prospective buyer or lessee for such real estate  
8 as an intra-company agent provided that:

9 (1) the licensee has executed a written consent for dual agency agreement;  
10 and

11 (2) the licensee has made the necessary disclosure and obtained consent as  
12 required by § 17-530(d).

13 (g) Before the licensee may present an offer to purchase or lease or negotiate the  
14 purchase or lease of real estate, the presumed buyer's or lessee's agency must be terminated  
15 and the buyer or lessee and the licensee shall enter into a brokerage agreement for that  
16 licensee to act as an exclusive buyer's or lessee's agent or as an intra-company agent for  
17 the buyer or lessee.

18 (h) The licensee acting as the presumed buyer's or lessee's agent shall comply  
19 with § 17-532 of this subtitle and has the duties stated in the required disclosure form  
20 under § 17-530 of this subtitle.

21 (i) At the first meeting of the licensee and the buyer or lessee, the licensee shall:

22 (1) orally advise the prospective buyer or lessee that the licensee will act  
23 as the buyer's or lessee's agent in locating residential real estate unless the buyer or lessee  
24 declines the agency; and

25 (2) provide the prospective buyer or lessee with a copy of the disclosure  
26 form required by § 17-530 of this subtitle, but the licensee is not required to obtain the  
27 signature of the buyer or lessee before or during the presumed agency relationship.

28 (j) A licensee acting as a presumed buyer's agent shall orally disclose that fact to  
29 the seller or lessor or the licensee acting as the agent of the seller or lessor at their first  
30 contact.]

31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
32 October 1, 2016.
