### 1 AN ACT concerning

### 2 Vehicle Equipment – Counterfeit and Nonfunctional Airbags – Prohibitions

3 FOR the purpose of prohibiting a person from importing, manufacturing, distributing, 4 selling, or offering for sale a counterfeit airbag or a nonfunctional airbag; prohibiting  $\mathbf{5}$ a person from installing a counterfeit airbag or a nonfunctional airbag in a motor 6 vehicle; prohibiting a person from selling or installing a device that causes the 7 vehicle diagnostic system to inaccurately indicate that the airbag is functional when 8 a counterfeit airbag, a nonfunctional airbag, or no airbag is installed; prohibiting a 9 person from representing to another person that a counterfeit airbag or a 10 nonfunctional airbag that is or will be installed in a motor vehicle is a functional 11 airbag; prohibiting a person from assisting in or causing a violation of this Act; 12establishing certain penalties for a violation of this Act; defining certain terms; and 13 generally relating to motor vehicle equipment and counterfeit airbags and 14 nonfunctional airbags.

6 COUNTERFEIT AIRBAG, NONFUNCTIONAL AIRBAG, OR NO AIRBAG IS INSTALLED;

7 (4) REPRESENT TO ANOTHER PERSON THAT A COUNTERFEIT AIRBAG
8 OR A NONFUNCTIONAL AIRBAG THAT IS OR WILL BE INSTALLED IN A MOTOR VEHICLE
9 IS A FUNCTIONAL AIRBAG; OR

10 (5) ASSIST IN OR CAUSE A VIOLATION OF THIS SUBSECTION.

11 (C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR 12 AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 5 YEARS OR A 13 FINE NOT EXCEEDING \$5,000 OR BOTH.

## 14 (D) THIS SECTION MAY BE CITED AS THE COUNTERFEIT AIRBAG 15 PREVENTION ACT.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 October 1, 2016.
