A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2015 – Worcester County –**
3 **Delmarva Discovery Center and Museum**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2015 to
5 add a grantee to certain grants; making this Act an emergency measure; and
6 generally relating to amending the Maryland Consolidated Capital Bond Loan of
7 2015.

8 BY repealing and reenacting, with amendments,
9 Chapter 495 of the Acts of the General Assembly of 2015
10 Section 1(3) Item ZA02(BC) and Item ZA03(BQ)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
 17 measure, is necessary for the immediate preservation of the public health or safety, has
 18 been passed by a yea and nay vote supported by three-fifths of all the members elected to
 19 each of the two Houses of the General Assembly, and shall take effect from the date it is
 20 enacted.
