## A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Right-of-Way Violations – Death or Serious Bodily Injury –**  
3 **Penalties**

4 FOR the purpose of establishing a certain mandatory fine for a violation of certain  
5 right-of-way provisions that contributes to an accident that results in death or  
6 serious bodily injury of another; authorizing the issuance of a certain citation by a  
7 law enforcement officer; requiring the District Court to establish a uniform citation  
8 form; requiring that the citation contain certain information; requiring that a law  
9 enforcement agency provide a copy of a citation to a District Court with venue;  
10 requiring that the District Court issue a summons to appear for trial to a person  
11 charged; prohibiting the District Court from establishing a schedule for the  
12 prepayment of the fine specified on a citation issued under this Act; requiring certain  
13 notice to a person charged; and generally relating to penalties for violating certain  
14 right-of-way provisions under certain circumstances.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
26 That the Laws of Maryland read as follows:

27 **Article – Transportation**

2 (a) In this section, "serious bodily injury" means an injury that:

3 (1) Creates a substantial risk of death;

4 (2) Causes serious permanent or serious protracted disfigurement;

5 (3) Causes serious permanent or serious protracted loss of the function of  
6 any body part, organ, or mental faculty; or

7 (4) Causes serious permanent or serious protracted impairment of the  
8 function of any bodily member or organ.

10 (a) If a person violates any provision of Title 21, Subtitle 4 of this article and the  
11 violation contributes to an accident that results in the death or, as defined in § 27-113 of  
12 this title, serious bodily injury of another, the person is guilty of a misdemeanor and on  
13 conviction:

14 (1) The person is subject to a fine of [not more than] \$1,000; and

15 (2) The Administration may suspend the person's license for not more than  
16 180 days.

17 **(B) A POLICE OFFICER MAY ISSUE A CITATION TO A PERSON WHO THE**  
18 **POLICE OFFICER HAS PROBABLE CAUSE TO BELIEVE HAS COMMITTED A VIOLATION**  
19 **UNDER THIS SECTION.**

20 **(C) A CITATION ISSUED UNDER THIS SECTION SHALL BE SIGNED BY THE**  
21 **POLICE OFFICER WHO ISSUES THE CITATION AND SHALL INCLUDE:**

22 **(1) THE NAME AND ADDRESS OF THE PERSON CHARGED;**

23 **(2) THE STATUTE ALLEGEDLY VIOLATED;**

24 **(3) THE DATE, LOCATION, AND TIME THAT THE VIOLATION**  
25 **OCCURRED;**

26 **(4) THE FINE IMPOSED;**

27 **(5) A NOTICE STATING THAT PREPAYMENT OF THE FINE IS NOT**  
28 **ALLOWED; AND**

1           **(6) A NOTICE THAT STATES THAT THE DISTRICT COURT SHALL**  
2 **PROMPTLY SEND THE PERSON A SUMMONS TO APPEAR FOR TRIAL.**

3           **(D) THE FORM OF THE CITATION SHALL BE UNIFORM THROUGHOUT THE**  
4 **STATE AND SHALL BE PRESCRIBED BY THE DISTRICT COURT.**

5           **(E) THE CHIEF JUDGE OF THE DISTRICT COURT MAY NOT ESTABLISH A**  
6 **SCHEDULE FOR THE PREPAYMENT OF A FINE UNDER THIS SECTION.**

7           **(F) (1) THE LAW ENFORCEMENT AGENCY OF THE POLICE OFFICER WHO**  
8 **ISSUED THE CITATION SHALL FORWARD TO THE DISTRICT COURT HAVING VENUE A**  
9 **COPY OF THE CITATION AND A REQUEST FOR TRIAL.**

10           **(2) THE DISTRICT COURT SHALL PROMPTLY SCHEDULE THE CASE**  
11 **FOR TRIAL AND SUMMON THE DEFENDANT TO APPEAR.**

12           **(G) IF A PERSON IS FOUND TO HAVE COMMITTED A VIOLATION UNDER THIS**  
13 **SECTION, ON CONVICTION THE PERSON IS SUBJECT TO THE PENALTIES SPECIFIED**  
14 **IN SUBSECTION (A) OF THIS SECTION.**

15           **[(b)] (H) Subject to the provisions of Title 12, Subtitle 2 of this article, a licensee**  
16 **may request a hearing on a license suspension imposed under this section.**

17           **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**  
18 **October 1, 2016.**
