# AMENDMENTS TO SENATE BILL 651 (First Reading File Bill)

#### AMENDMENT NO. 1

On page 1, in line 3, after "prekindergarten" insert "<u>kindergarten, first grade, or</u> <u>second grade</u>"; in line 4, after "schools" insert "<u>with certain exceptions for an expulsion</u> <u>required by federal law or a suspension for not more than a certain number of days</u> <u>under certain circumstances; requiring the principal or school administration to contact</u> <u>a student's parent or guardian under certain circumstances</u>"; and strike beginning with "authorizing" in line 4 down through "manner;" in line 6.

#### AMENDMENT NO. 2

On page 1, after line 21, insert:

# "<u>Preamble</u>

<u>WHEREAS</u>, Maryland public schools should provide practices that build fair processes into decision making, facilitate student learning, and allow for accountability and skill building, cooperation, and mutual understanding; and

WHEREAS, It is the intent of the General Assembly that school systems shall utilize restorative practices as an alternative to traditional school disciplinary practices to ensure that developmentally appropriate, age-appropriate, and proportional consequences are applied to a child's misbehavior in a way that supports personal growth and positive learning opportunities for all students; now, therefore,".

#### AMENDMENT NO. 3

On pages 5 and 6, strike in their entirety the lines beginning with line 29 on page 5 through line 7 on page 6, inclusive, and substitute:

"(B) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A STUDENT ENROLLED IN A PUBLIC PREKINDERGARTEN PROGRAM, KINDERGARTEN, FIRST GRADE, OR SECOND GRADE MAY NOT BE SUSPENDED OR EXPELLED FROM SCHOOL.

(2) <u>A STUDENT DESCRIBED UNDER PARAGRAPH (1) OF THIS</u> <u>SUBSECTION MAY ONLY BE:</u>

(I) <u>EXPELLED FROM SCHOOL IF REQUIRED BY FEDERAL</u> LAW; OR

(II) <u>SUSPENDED FOR NOT MORE THAN 5 SCHOOL DAYS IF</u> <u>THE SCHOOL ADMINISTRATION, IN CONSULTATION WITH A SCHOOL</u> <u>PSYCHOLOGIST OR OTHER MENTAL HEALTH PROFESSIONAL, DETERMINES THAT</u> <u>THERE IS AN IMMINENT THREAT OF SERIOUS HARM TO OTHER STUDENTS OR</u> <u>STAFF THAT CANNOT BE REDUCED OR ELIMINATED THROUGH INTERVENTIONS</u> <u>AND SUPPORTS.</u>

# (3) <u>THE PRINCIPAL OR SCHOOL ADMINISTRATION SHALL</u> <u>PROMPTLY CONTACT THE PARENT OR GUARDIAN OF A STUDENT SUSPENDED OR</u> <u>EXPELLED UNDER PARAGRAPH (2) OF THIS SUBSECTION.</u>".

On page 6, strike in their entirety lines 8 through 11, inclusive; in line 12, after "**PROVIDE**" insert "**INTERVENTION AND**"; and in line 20, strike "**SUPPORT**" and substitute "**INTERVENTION AND SUPPORT**".

On page 6 in line 12, and on page 7 in lines 1 and 4, strike "(**D**)", "(**E**)", and "(**F**)", respectively, and substitute "(<u>C)</u>", "(<u>D)</u>", and "(<u>E)</u>", respectively.
