AMENDMENTS TO HOUSE BILL 1113
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, after “Board;” insert “providing that the role of community health workers does not include providing clinical services;”.

On page 2, in line 7, strike “authorizing” and substitute “requiring, beginning on a certain date;”; and in lines 7 and 8, strike “to practice” and substitute “before practicing”.

AMENDMENT NO. 2

On page 4, in line 23, strike “AND”.

On page 5, in line 3, after “**ADVOCACY**” insert “;**AND**”

(4) IS PART OF A HEALTH CARE TEAM THAT MAY INCLUDE PHYSICIANS, NURSES, PSYCHIATRISTS, SOCIAL WORKERS, AND OTHER HEALTH CARE PROFESSIONALS WHO WORK CLOSELY WITH A COMMUNITY HEALTH WORKER TO PROVIDE COMPREHENSIVE AND COORDINATED CARE TO AN INDIVIDUAL;

and in line 21, strike “**CARE,**” and substitute “NONCLINICAL”.

On page 6, after line 2, insert:

“(C) THE ROLE OF COMMUNITY HEALTH WORKERS DOES NOT INCLUDE PROVIDING CLINICAL SERVICES, INCLUDING:

(1) DIAGNOSING HEALTH CARE CONDITIONS;

(Over)

(2) PROVIDING HEALTH CARE TREATMENT SERVICES; AND

(3) MAKING REFERRALS TO HEALTH CARE PROVIDERS OUTSIDE OF A COMMUNITY HEALTH WORKER'S HEALTH CARE TEAM AND WITHOUT THE SUPERVISION OF A LICENSED HEALTH CARE PROVIDER.”;

in line 10, strike “**SEVEN**” and substitute “**SIX**”; in line 21, strike “**AND**”; and in line 23, after “**OFFICERS**” insert “**; AND**”

(IX) ONE SHALL REPRESENT THE COMMUNITY BEHAVIORAL HEALTH ASSOCIATION OF MARYLAND”.

AMENDMENT NO. 3

On page 10, in line 9, strike “**AN**” and substitute “**BEGINNING ON OCTOBER 1, 2020, AN**”; in the same line, strike “**MAY**” and substitute “**SHALL**”; in line 10, strike “**TO**” and substitute “**BEFORE THE INDIVIDUAL MAY**”; and in line 19, strike “**2019**” and substitute “**2020**”.

On page 21, in line 3, strike “**2019**” and substitute “**2020**”; and in line 4, strike “**2020**” and substitute “**2021**”.
