## AMENDMENT NO. 3

On page 2, in line 20, after "plan" insert "<u>based on Augenblick, Palaich and</u> <u>Associates' January 2016 "A Comprehensive Analysis of Prekindergarten in Maryland"</u> <u>report submitted in accordance with Chapter 2 of the Acts of the General Assembly of</u> <u>2014</u>".

# AMENDMENT NO. 4

On page 3, strike beginning with "shall" in line 9 down through "2017" in line 10 and substitute "<u>is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three-fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted"; and in line 10, strike "and, at the end of May 31, 2018," and substitute "from the date it is enacted and, at the end of the 1-year period.".</u>
