in line 18, before "NOTWITHSTANDING" insert "<u>(A)</u>"; in line 19, strike "COUNTY" and substitute "<u>HOMEOWNERS ASSOCIATION OR, IF CONTROL OF THE GOVERNING</u> <u>BODY HAS NOT YET TRANSITIONED TO THE LOT OWNERS, THE DECLARANT</u>"; in line 20, strike "TO EACH LOT OWNER, IN WRITING," and substitute "<u>IN ACCORDANCE</u> <u>WITH SUBSECTION (B) OF THIS SECTION</u>"; in line 21, strike "OWNED BY" and substitute "<u>LOCATED ON PROPERTY THAT HAS BEEN TRANSFERRED TO</u>"; and after line 22, insert:

# "(B) <u>The notice requirement under subsection (A) of this</u> <u>Section shall be satisfied by:</u>

(1) PROVIDING WRITTEN NOTICE ABOUT THE SALE TO EACH LOT OWNER; OR

(2) (I) POSTING A SIGN ABOUT THE SALE ON THE PROPERTY TO BE SOLD, IN A MANNER SIMILAR TO SIGNAGE REQUIRED FOR A ZONING MODIFICATION; AND

(II) IF THE HOMEOWNERS ASSOCIATION HAS A WEB SITE, PROVIDING NOTICE ABOUT THE SALE ON THE HOME PAGE OF THE WEB SITE OF THE HOMEOWNERS ASSOCIATION.".
