3 FOR the purpose of requiring the Carroll County Board of Education to hold a public 4 hearing on a proposed annual school budget a certain amount of time before 5 submitting the budget to the County Commissioners of Carroll County under a 6 certain provision of law; requiring the county board to publish notice of the time and 7 place of the public hearing in a certain manner, maintain certain copies of the 8 proposed budget for inspection by the public during certain hours, and provide copies 9 of the proposed budget to certain newspapers and the county library; authorizing the 10 county board to hold additional public hearings to obtain certain information; and 11 generally relating to the procedures for preparing a budget for the Carroll County public school system. 12

28 (b) (1) Each county board shall submit an annual school budget in writing to 29 the county commissioners, county council, or the county executive.

OBTAIN INFORMATION RELEVANT TO THE PROPOSED BUDGET OR ANY PORTION OF

- 1 (2) The budget shall be submitted not less than 45 days before the date for 2 levying local taxes or on an earlier date on or after March 1 as may be requested by the 3 county fiscal authority.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 October 1, 2017.
