- 3 (a) In this subtitle the following words have the meanings indicated.
- 4 (u) (1) "Proceeds" means the part of the amount of money bet through video lottery terminals and table games that is not returned to successful players but is otherwise allocated under this subtitle.
- 7 "PROCEEDS" MAY (2)(I) \mathbf{BE} REDUCED CONSISTENT WITH 8 COMMISSION ACCORDANCE REGULATIONS **ADOPTED** \mathbf{BY} THE IN WITH 9 SUBPARAGRAPH (II) OF THIS PARAGRAPH.

- (ii) After the first fiscal year of operations, the exclusion specified in subparagraph (i) of this paragraph may not exceed a percentage established by the Commission by regulation of the proceeds received from video lottery terminals and table games in the prior fiscal year by the video lottery operation licensee under § 9–1A–27(a)(2), (c)(1)(ii), and (d)(1) of this subtitle.

- 24 (a) (1) Except as provided in paragraphs (2) and (3) of this subsection, all proceeds from the operation of video lottery terminals and table games shall be electronically transferred daily into the State Lottery Fund established under Subtitle 1 of this title and distributed as provided under § 9–1A–27 of this subtitle.
- 28 (2) The requirement under paragraph (1) of this subsection does not apply on a day when State government is closed.
- 30 (3) The amount from the proceeds of video lottery terminals to be paid to video lottery operation licensees under § 9–1A–27(a)(2) and (7), (b), and (c)(1)(ii) and (2) of this subtitle shall be retained by the licensee.
 - (D) THE COMMISSION SHALL ADOPT REGULATIONS THAT:
