1 AN ACT concerning

2 **Motor Vehicles – Electronic Inspection Certificates for Used Vehicles – Sunset**
3 **Extension**

4 FOR the purpose of extending the termination date for certain provisions of the used vehicle
5 inspection law applicable to the electronic submission of an inspection certificate.

6 BY repealing and reenacting, without amendments,

13 Section 3

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

15 That the Laws of Maryland read as follows:

16 **Article – Transportation**

17 23–101.

18 (a) In this subtitle the following words have the meanings indicated.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.

Underlining indicates amendments to bill.

~~Strike out~~ indicates matter stricken from the bill by amendment or deleted from the law by amendment.



1 (b) "Division" means the Automotive Safety Enforcement Division of the
2 Department of State Police.

3 (e) "Inspection certificate" means a certification by an inspection station, in a
4 format established by the Division, that:

5 (1) Certifies that, as of its date, a specified vehicle meets or exceeds the
6 standards for equipment established under this title; and

7 (2) Identifies the inspection station and the registered individual who
8 personally inspected the vehicle.

9 23-108.1.

10 For vehicle titling and registration purposes, the Division:

11 (1) Shall establish the manner and format for the submission of an
12 inspection certificate for the transfer of a used motor vehicle;

13 (2) May authorize electronic submission of the inspection certificate; and

14 (3) Shall authorize the use of an inspection certificate form for the
15 submission of the inspection certificate.

16 **Chapter 91 of the Acts of 2014**

17 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
18 1, 2014. It shall remain effective for a period of [3] 6 years and, at the end of June 30,
19 [2017] 2020, with no further action required by the General Assembly, this Act shall be
20 abrogated and of no further force and effect.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
22 1, 2017.
