A BILL ENTITLED

1 AN ACT concerning

2 **Environment – Solid Waste and Recycling Facilities**

3 FOR the purpose of requiring the Department of the Environment to adopt certain
4 regulations relating to recycling facilities, including conditions for permit
5 exemptions; providing that certain enforcement provisions apply to certain
6 violations; requiring the Department to convene and consult with a certain
7 workgroup in developing certain regulations; requiring the workgroup to include
8 representatives of certain entities; altering certain defined terms; defining certain
9 terms; and generally relating to solid waste and recycling.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
26 That the Laws of Maryland read as follows:

1 **Article – Environment**

2 9–101.

3 (j) (1) “Solid waste” means any garbage, refuse, sludge, or liquid from
4 industrial, commercial, mining, or agricultural operations or from community activities.

5 (2) “Solid waste” includes:

6 (i) Scrap tires as defined in § 9–201 of this title; [and]

7 (ii) Organic material capable of being composted that is not
8 composted in accordance with regulations adopted under § 9–1725(b) of this title;9 **(III) MATERIALS THAT ARE MANAGED AT A RECYCLING FACILITY**
10 **AND ARE NOT RECYCLABLE MATERIALS AS DEFINED IN § 9–1701 OF THIS TITLE; AND**11 **(IV) RECYCLABLE MATERIALS AS DEFINED IN § 9–1701 OF THIS**
12 **TITLE THAT ARE NOT:**13 **1. RETURNED TO THE MARKETPLACE IN THE FORM OF A**
14 **RAW MATERIAL OR PRODUCT WITHIN 1 CALENDAR YEAR FROM THE TIME THE**
15 **RECYCLABLE MATERIALS ARE RECEIVED; OR**16 **2. OTHERWISE MANAGED IN ACCORDANCE WITH**
17 **REGULATIONS ADOPTED UNDER § 9–1713 OF THIS TITLE.**

18 (3) “Solid waste” does not include:

19 (i) Solid or dissolved material in domestic sewage or in irrigation
20 return flows;

21 (ii) Compost as defined in § 9–1701 of this title; [or]

22 (iii) Organic material capable of being composted that is composted
23 in accordance with regulations adopted under § 9–1725(b) of this title; **OR**24 **(IV) MATERIALS THAT ARE MANAGED AT A RECYCLING FACILITY**
25 **IN ACCORDANCE WITH REGULATIONS ADOPTED UNDER § 9–1713 OF THIS TITLE.**

26 9–1701.

27 (m) “Recyclable materials” means those materials that:

1 (1) Would otherwise become solid waste for disposal in a refuse disposal
2 system; and

3 (2) May be collected, separated, composted, or processed and returned to
4 the marketplace in the form of raw materials or products.

5 (n) (1) "Recycling" means any process in which recyclable materials are
6 collected, separated, or processed and returned to the marketplace in the form of raw
7 materials or products.

8 (2) "Recycling" includes composting.

9 (o) "Recycling services" means the services provided by persons engaged in the
10 business of recycling, including the collection, processing, storage, purchase, sale, or
11 disposition of recyclable materials.

12 **9-1713.**

13 (A) (1) IN THIS SECTION, "RECYCLING FACILITY" MEANS A FACILITY
14 THAT PROVIDES RECYCLING SERVICES.

15 (2) "RECYCLING FACILITY" DOES NOT INCLUDE:

16 (I) A COMPOSTING FACILITY;

17 (II) A FACILITY THAT REQUIRES A NATURAL WOOD WASTE
18 RECYCLING FACILITY PERMIT IN ACCORDANCE WITH THIS SUBTITLE; OR

19 (III) A FACILITY THAT REQUIRES A SEWAGE SLUDGE
20 UTILIZATION PERMIT IN ACCORDANCE WITH SUBTITLE 2 OF THIS TITLE.

21 (B) THE DEPARTMENT SHALL ADOPT REGULATIONS TO:

22 (1) ESTABLISH CONDITIONS UNDER WHICH A RECYCLING FACILITY
23 DOES NOT REQUIRE A REFUSE DISPOSAL PERMIT UNDER SUBTITLE 2 OF THIS TITLE;
24 AND

25 (2) EXEMPT CERTAIN MATERIALS THAT ARE MANAGED AT A
26 RECYCLING FACILITY FROM BEING DESIGNATED AS SOLID WASTE.

27 (C) THE REGULATIONS ADOPTED UNDER SUBSECTION (B) OF THIS SECTION
28 MAY INCLUDE:

1 **(1) DESIGN, CONSTRUCTION, AND OPERATIONAL CONDITIONS FOR**
2 **RECYCLING FACILITIES TO PROTECT PUBLIC HEALTH AND THE ENVIRONMENT AND**
3 **MINIMIZE NUISANCES;**

4 **(2) A TIERED SYSTEM OF PERMITS OR APPROVALS FOR RECYCLING**
5 **FACILITIES BASED ON THE QUANTITY OF MATERIAL MANAGED, THE METHODS OF**
6 **MANAGEMENT AND STORAGE, AND OTHER FACTORS DETERMINED BY THE**
7 **DEPARTMENT TO BE APPROPRIATE; AND**

8 **(3) EXCEPTIONS TO ANY REQUIREMENT TO OBTAIN A RECYCLING**
9 **FACILITY PERMIT OR APPROVAL.**

10 **(D) SECTIONS 9–334 THROUGH 9–342 OF THIS TITLE AND § 10–104 OF THIS**
11 **ARTICLE APPLY TO VIOLATIONS OF:**

12 **(1) THIS SECTION;**

13 **(2) ANY REGULATION ADOPTED UNDER THIS SECTION; OR**

14 **(3) ANY ORDER OR PERMIT ISSUED UNDER THIS SECTION.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That:

16 (a) In developing the regulations applicable to recycling facilities required under
17 this Act, the Department of the Environment shall convene and consult with a workgroup
18 of affected stakeholders.

19 (b) The workgroup convened under subsection (a) of this section shall include
20 representatives from:

21 (1) the Maryland Association of Counties;

22 (2) the Maryland–Delaware Solid Waste Association;

23 (3) the Maryland Environmental Service;

24 (4) the Northeast Maryland Waste Disposal Authority;

25 (5) the Maryland Recycling Network;

26 (6) businesses that will be directly impacted by the required regulations;

27 and

28 (7) any other organization or entity, as determined by the Department.

1 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2017.
