A BILL ENTITLED

1 AN ACT concerning

2 **Healthy Aging Program**

3 FOR the purpose of authorizing the Department of Aging to accept and use grant funds to
4 benefit Maryland's older adults under certain circumstances; establishing the
5 Healthy Aging Program in the Department of Aging; specifying the purposes of the
6 Program; providing for funding for the Program; authorizing the Secretary of Aging
7 to adopt certain regulations; and generally relating to the Healthy Aging Program.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Human Services**

22 10–205.

23 (a) The Secretary shall prepare and submit a budget for the Department.

1 (b) The Secretary may accept and use any State or federal funds for the purposes
2 specified in this title.

3 (c) **THE SECRETARY MAY ACCEPT AND USE ANY FEDERAL OR PRIVATE**
4 **GRANT FUNDS IF:**

5 (1) **THE GRANT IS FOR PURPOSES THAT WILL BENEFIT MARYLAND'S**
6 **OLDER ADULTS; AND**

7 (2) **THE GRANT FUNDS ARE ACCEPTED AND ACCOUNTED FOR IN**
8 **ACCORDANCE WITH THE STATE FINANCE AND PROCUREMENT ARTICLE.**

9 **SUBTITLE 11. HEALTHY AGING PROGRAM.**

11 (A) **THERE IS A HEALTHY AGING PROGRAM IN THE DEPARTMENT.**

12 (B) **THE PURPOSES OF THE PROGRAM ARE TO:**

13 (1) **PROMOTE HEALTHY AGING AND HEALTHY LIVING BY OLDER**
14 **ADULTS AT BOTH THE STATE AND LOCAL LEVELS;**

15 (2) **ENCOURAGE AGING SAFELY AT HOME AND IN THE COMMUNITY;**

16 (3) **RAISE PUBLIC AWARENESS ABOUT THE IMPORTANCE OF HEALTHY**
17 **AGING AND AGING SAFELY FOR BOTH INDIVIDUALS AND THE PUBLIC AT LARGE;**

18 (4) **EVALUATE THE NEED FOR IMPROVING THE QUALITY AND**
19 **ACCESSIBILITY OF EXISTING HEALTHY AGING OPPORTUNITIES AND SERVICES;**

20 (5) **IMPROVE THE QUALITY OF LIFE AND CONTAIN HEALTH CARE**
21 **COSTS OF OLDER ADULTS;**

22 (6) **PROVIDE COMPETITIVE FUNDING GRANTS TO DESIGN AND TEST**
23 **PROGRAMS AND SERVICES THAT HELP OLDER ADULTS ACHIEVE HEALTHY AND SAFE**
24 **AGING AND HEALTHY LIVING; AND**

25 (7) **PUBLICLY DISSEMINATE THE OUTCOMES OF THE GRANTS**
26 **AWARDED UNDER THE PROGRAM.**

27 **10-1102.**

1 **(A) FUNDING FOR THE HEALTHY AGING PROGRAM SHALL BE AS PROVIDED**
2 **IN THE STATE BUDGET.**

3 **(B) THE SECRETARY MAY ACCEPT MONEY PROVIDED BY OTHER PUBLIC**
4 **AND PRIVATE SOURCES, INCLUDING FEDERAL FUNDS, TO PROVIDE GRANTS UNDER**
5 **THE PROGRAM.**

6 **(C) THE SECRETARY MAY ADOPT REGULATIONS TO IMPLEMENT THE**
7 **PROGRAM.**

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 October 1, 2017.
