1 AN ACT concerning

### 2 **Healthy Aging Program**

3 FOR the purpose of authorizing the Department of Aging to accept and use grant funds to  
4 benefit Maryland's older adults under certain circumstances; establishing the  
5 Healthy Aging Program in the Department of Aging; specifying the purposes of the  
6 Program; providing for funding for the Program; authorizing the Secretary of Aging  
7 to adopt certain regulations; and generally relating to the Healthy Aging Program.

8 BY repealing and reenacting, with amendments,

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
20 That the Laws of Maryland read as follows:

22 **ACCESSIBILITY OF EXISTING HEALTHY AGING OPPORTUNITIES AND SERVICES;**23 (5) **IMPROVE THE QUALITY OF LIFE AND CONTAIN HEALTH CARE**  
24 **COSTS OF OLDER ADULTS;**25 (6) **PROVIDE COMPETITIVE FUNDING GRANTS TO DESIGN AND TEST**  
26 **PROGRAMS AND SERVICES THAT HELP OLDER ADULTS ACHIEVE HEALTHY AND SAFE**

1           **(7) PUBLICLY DISSEMINATE THE OUTCOMES OF THE GRANTS**  
2 **AWARDED UNDER THE PROGRAM.**

4           **(A) FUNDING FOR THE HEALTHY AGING PROGRAM SHALL BE AS PROVIDED**  
5 **IN THE STATE BUDGET.**

6           **(B) THE SECRETARY MAY ACCEPT MONEY PROVIDED BY OTHER PUBLIC**  
7 **AND PRIVATE SOURCES, INCLUDING FEDERAL FUNDS, TO PROVIDE GRANTS UNDER**  
8 **THE PROGRAM.**

9           **(C) THE SECRETARY MAY ADOPT REGULATIONS TO IMPLEMENT THE**  
10 **PROGRAM.**

11           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
12 October 1, 2017.
