1 AN ACT concerning

Public Service Commission – Membership

- FOR the purpose of altering the manner of appointing commissioners to the Public Service
 Commission; requiring that each commissioner reside in and represent one of certain
 defined areas of the State; altering the manner of appointing the Chairman of the
 Commission; providing that the term of the Chairman is coterminous with the
 individual's term as a commissioner; providing for the application of this Act; and
 generally relating to the Public Service Commission.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

 - 17 2–102.

(a) The Commission consists of five commissioners, appointed by the Governorwith the advice and consent of the Senate.

20 (b) (1) Each commissioner shall be a registered voter of the State.

21 (2) EACH COMMISSIONER SHALL RESIDE IN AND REPRESENT ONE OF 22 THE FOLLOWING AREAS:

1 (b) [(1)] The term of the Chairman is [5 years and begins on July 1] 2 COTERMINOUS WITH THE INDIVIDUAL'S TERM AS A COMMISSIONER.

3 [(2) At the end of a term, the Chairman continues to serve until a successor 4 qualifies.

5 (3) A Chairman who is appointed after a term has begun serves for the rest 6 of the term and until a successor qualifies.]

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to 8 apply only prospectively and may not be applied or interpreted to have any effect on or 9 application to the term of the Chairman or any other member of the Public Service 10 Commission serving before the effective date of this Act.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June1, 2017.
