4 FOR the purpose of prohibiting a consumer reporting agency from charging a consumer a
5 fee for placing a security freeze *if the consumer has not previously requested the*
6 *placement of a security freeze from the consumer reporting agency;* ~~temporarily lifting~~

27 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

28 That the Laws of Maryland read as follows:

29 **Article – Commercial Law**

30 14–1212.1.

31 (a) (1) In this section the following words have the meanings indicated.

32 (3) “Security freeze” means a restriction placed on a consumer’s consumer
 33 report at the request of the consumer that prohibits a consumer reporting agency from
 34 releasing the consumer’s consumer report or any information derived from the consumer’s
 35 consumer report without the express authorization of the consumer.

36 (i) (1) Except as provided in paragraph (2) of this subsection, a consumer may
 37 not be charged for any service relating to a security freeze.

1 (2) A consumer reporting agency may charge a reasonable fee, not
2 exceeding \$5, for each placement, temporary lift, or removal of a security freeze.

3 (3) Notwithstanding paragraph (2) of this subsection, a consumer reporting
4 agency may not charge any fee under this section to a consumer who:

5 (i) 1. Has obtained a report of alleged identity fraud against the
6 consumer under § 8–304 of the Criminal Law Article or an identity theft passport under §
7 8–305 of the Criminal Law Article; and

8 ~~(ii)~~ 2. Provides a copy of the report or passport to the consumer
9 reporting agency; OR

10 (II) REQUESTS THE PLACEMENT OF A SECURITY FREEZE IF THE
11 CONSUMER HAS NOT PREVIOUSLY REQUESTED THE PLACEMENT OF A SECURITY
12 FREEZE FROM THE CONSUMER REPORTING AGENCY.

24 (j) At any time that a consumer is entitled to receive a summary of rights under
25 § 609 of the federal Fair Credit Reporting Act or § 14–1206 of this subtitle, the following
26 notice shall be included:

27 “NOTICE

28 You have a right, under § 14–1212.1 of the Commercial Law Article of the Annotated
29 Code of Maryland, to place a security freeze on your credit report. The security freeze will
30 prohibit a consumer reporting agency from releasing your credit report or any information
31 derived from your credit report without your express authorization. The purpose of a
32 security freeze is to prevent credit, loans, and services from being approved in your name
33 without your consent.

1 You may elect to have a consumer reporting agency place a security freeze on your
2 credit report by written request sent by certified mail or by electronic mail or the Internet
3 if the consumer reporting agency provides a secure electronic connection. The consumer
4 reporting agency must place a security freeze on your credit report within 3 business days
5 after your request is received. Within 5 business days after a security freeze is placed on
6 your credit report, you will be provided with a unique personal identification number or
7 password to use if you want to remove the security freeze or temporarily lift the security
8 freeze to release your credit report to a specific person or for a specific period of time. You
9 also will receive information on the procedures for removing or temporarily lifting a
10 security freeze.

11 If you want to temporarily lift the security freeze on your credit report, you must
12 contact the consumer reporting agency and provide all of the following:

13 (1) The unique personal identification number or password provided by the
14 consumer reporting agency;

15 (2) The proper identifying information to verify your identity; and

16 (3) The proper information regarding the person who is to receive the credit
17 report or the period of time for which the credit report is to be available to users of the
18 credit report.

19 A consumer reporting agency must comply with a request to temporarily lift a
20 security freeze on a credit report within 3 business days after the request is received, or
21 within 15 minutes for certain requests. A consumer reporting agency must comply with a
22 request to remove a security freeze on a credit report within 3 business days after the
23 request is received.

24 If you are actively seeking credit, you should be aware that the procedures involved
25 in lifting a security freeze may slow your own applications for credit. You should plan ahead
26 and lift a security freeze, either completely if you are seeking credit from a number of
27 sources, or just for a specific creditor if you are applying only to that creditor, a few days
28 before actually applying for new credit.

29 A consumer reporting agency may charge a reasonable fee not exceeding \$5 for each
30 placement, temporary lift, or removal of a security freeze. However, a consumer reporting
31 agency may not charge any fee to a consumer who, at the time of a request to place,
32 temporarily lift, or remove a security freeze, presents to the consumer reporting agency a
33 police report of alleged identity fraud against the consumer or an identity theft passport. **A**
