BY repealing and reenacting, with amendments, Article – Economic Development Section 3–101 and 3–103 through 3–109 to be under the amended subtitle "Subtitle 1. Maryland Manufacturing Advisory Board" Annotated Code of Maryland (2008 Volume and 2016 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Economic Development Subtitle 1.
