1 AN ACT concerning

2 **State Board of Nursing – Registered Nurses and Licensed Practical Nurses**
3 **– Renewal of Licenses – Continuing Education Units**

4 FOR the purpose of altering the requirements for renewing certain licenses by authorizing
5 certain registered nurses and licensed practical nurses to renew a license if the
6 registered nurse or licensed practical nurse submits to the State Board of Nursing
7 certain evidence of completion of a certain number of continuing education units as
8 required by regulations adopted by the Board; and generally relating to the renewal
9 of licenses of registered nurses and licensed practical nurses.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Health Occupations**

18 8–312.

19 (c) Before a license expires, the licensee periodically may renew it for an
20 additional term, if the licensee:

- 1 (1) Otherwise is entitled to be licensed;
- 2 (2) Pays to the Board:
- 3 (i) A renewal fee set by the Board; or
- 4 (ii) A renewal fee that is set by the Board if the licensee certifies to
- 5 the Board that the licensee provides professional services only as a volunteer; and
- 6 (3) Submits to the Board by paper application or electronic means:
- 7 (i) A renewal application on the form that the Board requires; and
- 8 (ii) Satisfactory evidence of completion of:
- 9 1. 1,000 hours of active nursing practice within the 5-year
- 10 period immediately preceding the date of renewal;
- 11 2. A course of instruction, commonly known as a refresher
- 12 course, approved by the Board; [or]
- 13 3. A preceptorship program provided by an employer and
- 14 approved by the Board; **OR**
- 15 4. **A MINIMUM NUMBER OF CONTINUING EDUCATION**
- 16 **UNITS AS REQUIRED BY REGULATIONS ADOPTED BY THE BOARD.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect

18 October 1, 2017.
