CHAPTER _____

1 AN ACT concerning

2 **Adult Entertainment Establishments – National Human Trafficking Resource**
3 **Center Hotline Information – Sign Posting Requirements**

4 FOR the purpose of requiring the owner of a certain adult entertainment establishment to
5 post a certain information sign in each restroom of the adult entertainment
6 establishment in a certain manner; requiring a certain agency that determines a
7 certain violation has occurred to notify the owner of the adult entertainment
8 establishment or the owner's agent of the violation; providing that the owner is
9 subject to a certain civil penalty if the owner does not post certain signs within a
10 certain period of time after receiving a certain notice; defining certain terms; and
11 generally relating to posting signs with information about the National Human
12 Trafficking Resource Center Hotline in adult entertainment establishments.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Business Regulation**

4 15–207.

5 (a) (1) The Department shall design a sign that states the following:

6 “REPORT HUMAN TRAFFICKING: National Human Trafficking Resource
7 Center — 1–888–373–7888. CALL FOR HELP IF YOU OR SOMEONE YOU KNOW:

- 8 • Is being forced to have sex without consent
9 • Has had an ID or documents taken away
10 • Is being threatened by or is in debt to an employer
11 • Wants to leave a job but cannot freely do so.

12 TOLL–FREE. 24/7. CONFIDENTIAL. INTERPRETERS AVAILABLE.

13 This sign is required under State law.”

14 (2) The sign shall:

15 (i) be at least 3 by 5 inches in size;

16 (ii) contain the text required under paragraph (1) of this subsection
17 in English, Spanish, and any other languages required by the federal Voting Rights Act;

18 (iii) draw attention to the phone number of the National Human
19 Trafficking Resource Center Hotline by showing the phone number in bold type; and

20 (iv) be placed on the Department Web site.

22 (a) (1) In this section[,] THE FOLLOWING WORDS HAVE THE MEANINGS
23 INDICATED.

24 (2) “ADULT ENTERTAINMENT” MEANS LIVE ENTERTAINMENT:

25 (I) IN WHICH INDIVIDUALS APPEAR FOR PUBLIC VIEW IN A
26 STATE OF NUDITY OR PARTIAL NUDITY;

27 (II) THAT IS INTENDED TO PROVIDE SEXUAL STIMULATION OR
28 SEXUAL GRATIFICATION;

1 (III) THAT IS DISTINGUISHED OR CHARACTERIZED BY AN
2 EMPHASIS ON MATERIAL THAT DEPICTS, DESCRIBES, OR RELATES TO:

3 1. HUMAN GENITALS IN A DISCERNIBLE STATE OF
4 SEXUAL STIMULATION OR AROUSAL; OR

5 2. ACTS OF HUMAN MASTURBATION, SEXUAL
6 INTERCOURSE, SODOMY, OR PHYSICAL CONTACT WITH AN INDIVIDUAL'S CLOTHED
7 OR UNCLOTHED GENITALS, PUBIC AREA, BUTTOCKS, OR, IF THE INDIVIDUAL IS
8 FEMALE, BREASTS; OR

9 (IV) THAT, APPLYING CONTEMPORARY STANDARDS, THE
10 AVERAGE INDIVIDUAL WOULD FIND, TAKEN AS A WHOLE, APPEALS TO THE
11 PRURIENT INTEREST.

12 (3) "ADULT ENTERTAINMENT ESTABLISHMENT" MEANS A BUSINESS
13 ESTABLISHMENT WHERE ADULT ENTERTAINMENT IS OFFERED.

14 (4) ["truck stop"] "TRUCK STOP" means a facility:

15 [(1)] (I) the primary purpose of which is to provide services to
16 long-haul truck drivers; and

17 [(2)] (II) that provides:

18 [(i)] 1. shower facilities to the truck drivers for a fee; or

19 [(ii)] 2. parking for the truck drivers' vehicles.

20 (b) (1) The owner of a privately owned bus station [or], truck stop, OR ADULT
21 ENTERTAINMENT ESTABLISHMENT shall post the National Human Trafficking Resource
22 Center Hotline information sign described in § 15-207 of this article in each restroom of
23 the bus station [or], truck stop, OR ADULT ENTERTAINMENT ESTABLISHMENT.

24 (2) A sign required under this section shall be posted:

25 (i) on the inside of each stall door in the restroom; or

26 (ii) on the back of the door at the entrance to the restroom.

27 (c) (1) An agency that enforces this section and determines that a violation of
28 this section has occurred shall notify the business owner of the bus station [or], truck stop,
29 OR ADULT ENTERTAINMENT ESTABLISHMENT, or the business owner's agent, of the
30 violation.

1 (2) If the business owner of the bus station [or], truck stop, **OR ADULT**
 2 **ENTERTAINMENT ESTABLISHMENT** does not post signs as required under this section
 3 within 24 hours after receiving the notice required under paragraph (1) of this subsection,
 4 the business owner is subject to a civil penalty not exceeding \$1,000.

5 (3) For each restroom in which a business owner fails to post a sign in
 6 accordance with this section, the business owner is subject to a separate civil penalty.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 8 October 1, 2017.
