Washington Metrorail Safety Commission Membership Act

3 FOR the purpose of requiring that certain members of the board of directors of the 4 Washington Metrorail Safety Commission be appointed by the Governor with the 5 advice and consent of the Senate; requiring one regular member of the board of 6 directors of the Commission who is appointed by the Governor to be a resident of 7 Montgomery County or Prince George's County; providing that the regular member of the board of directors of the Commission who is a resident of Montgomery County 8 9 or Prince George's County may not be succeeded by an individual who is a resident 10 of the same county; making this Act contingent on the taking effect of another Act; 11 and generally relating to the membership of the Washington Metrorail Safety 12 Commission.
