A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County – Alcoholic Beverages – Class A Licenses**

3 **MC 20–17**

4 FOR the purpose of authorizing the Montgomery County Board of License Commissioners,
5 if an individual holds a Class A alcoholic beverages license issued by any board of
6 license commissioners in the State, to issue a second Class A license for use in
7 Montgomery County under certain circumstances; and generally relating to alcoholic
8 beverages licenses in Montgomery County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Alcoholic Beverages**

23 (a) Except as otherwise provided in Division II of this article or Title 3, Title 4, or
24 Title 5 of this division, more than one license may not be issued:

2 (2) for the use of a partnership, a corporation, an unincorporated
3 association, or a limited liability company.

4 (b) Except as otherwise provided in Division II of this article or Title 3, Title 4, or
5 Title 5 of this division, an individual may not be issued in the State more than one Class A,
6 Class C, or Class D license for the use of:

7 (1) that individual; or

8 (2) a partnership, a corporation, an unincorporated association, or a
9 limited liability company.

11 This title applies only in Montgomery County.

13 **IF AN INDIVIDUAL HOLDS A CLASS A LICENSE THAT IS ISSUED BY ANY BOARD**
14 **OF LICENSE COMMISSIONERS IN THE STATE, THE MONTGOMERY COUNTY BOARD**
15 **OF LICENSE COMMISSIONERS MAY ISSUE A SECOND CLASS A LICENSE FOR USE IN**
16 **MONTGOMERY COUNTY BY:**

17 **(1) THAT INDIVIDUAL; OR**

18 **(2) A PARTNERSHIP, A CORPORATION, AN UNINCORPORATED**
19 **ASSOCIATION, OR A LIMITED LIABILITY COMPANY.**

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
21 1, 2017.
