5 (2) "ELECTRONIC CIGARETTE DEVICE" INCLUDES AN ELECTRONIC 6 CIGARETTE, CIGAR, CIGARILLO, OR PIPE.

7 (3) "ELECTRONIC CIGARETTE DEVICE" DOES NOT INCLUDE A 8 PRODUCT APPROVED BY THE U.S. FOOD AND DRUG ADMINISTRATION FOR SALE AS 9 A DRUG DELIVERY OR MEDICAL DEVICE.

18 **(2)** THE ESCAPING VAPOR OR AEROSOL FROM AN ELECTRONIC 19 CIGARETTE DEVICE OR VAPOR OR AEROSOL EXHALED BY THE USER OF THE DEVICE.

(1) An indoor area or a portion of an indoor area accessible to the public by
 either invitation or permission; or

(2) An indoor area of any establishment licensed or permitted under the

It is the intent of the General Assembly that the State protect the public and employees from involuntary exposure to environmental tobacco smoke AND VAPOR in indoor areas open to the public, indoor places of employment, and certain designated private areas.

7 The purpose of this subtitle is to preserve and improve the health, comfort, and 8 environment of the people of the State by limiting exposure to environmental tobacco smoke 9 AND VAPOR.

11 Except as provided in § 24–505 of this subtitle, beginning on February 1, 2008, a 12 person may not smoke in:

13 (1) An indoor area open to the public;
