## A BILL ENTITLED

1 AN ACT concerning

2 **Redistricting Reform Act of 2017**

3 FOR the purpose of prohibiting multimember delegate districts; creating the General  
4 Assembly and Congressional Legislative Redistricting and Apportionment  
5 Commission; requiring the Commission to divide the State to create certain General  
6 Assembly legislative districts and congressional districts; establishing exclusive and  
7 original jurisdiction for the Court of Appeals to establish legislative and  
8 congressional districts under certain circumstances; providing for the membership,  
9 qualifications, and duties of the Commission; specifying certain requirements for the  
10 adoption of redistricting plans by the Commission; specifying that the redistricting  
11 plans meet certain standards and requirements; prohibiting the Commission from  
12 considering certain factors in adopting redistricting plans; requiring the Secretary  
13 of State to submit the Commission's final certified map and plan for General  
14 Assembly legislative districts and congressional districts to the presiding officers of  
15 the General Assembly; requiring the presiding officers to introduce separate bills for  
16 the General Assembly legislative districts and congressional districts; specifying  
17 that the maps and plans become law only on adoption by two-thirds of the members  
18 of each house of the General Assembly; providing that the Commission shall submit  
19 an alternative map and plan if the General Assembly fails to adopt a previously  
20 submitted map and plan; requiring the Legislative Auditor to establish and  
21 administer an application process for individuals seeking appointment to the  
22 Commission; prohibiting certain individuals from serving as a member of the  
23 Commission; authorizing the Legislative Auditor to disqualify certain applicants  
24 seeking membership on the Commission; requiring the Legislative Auditor to  
25 establish an Applicant Review Panel to identify and establish certain applicant pools  
26 from which certain members of the Commission are to be selected; requiring the  
27 Legislative Auditor to select at random a certain number of names from the applicant  
28 pools for membership on the Commission; requiring the Commission to elect a chair  
29 and establish certain rules and procedures; making Commission meetings and  
30 records subject to State laws governing open meetings and public records; providing  
31 that the maps and plans drawn by the Commission are final and subject to review

32 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
 33 (Three–fifths of all the members elected to each of the two Houses concurring), That it be  
 34 proposed that the Maryland Constitution read as follows:

35 **Article III – Legislative Department**

36 3.

37 The State shall be divided by law into legislative districts for the election of members  
 38 of the Senate and the House of Delegates. Each legislative district shall contain one (1)

1 Senator and three (3) Delegates. Nothing herein shall prohibit the subdivision of any one  
2 or more of the legislative districts for the purpose of electing members of the House of  
3 Delegates into three (3) single-member delegate districts [or one (1) single-member  
4 delegate district and one (1) multi-member delegate district].

5 [5.

6 Following each decennial census of the United States and after public hearings, the  
7 Governor shall prepare a plan setting forth the boundaries of the legislative districts for  
8 electing of the members of the Senate and the House of Delegates.

9 The Governor shall present the plan to the President of the Senate and Speaker of  
10 the House of Delegates who shall introduce the Governor's plan as a joint resolution to the  
11 General Assembly, not later than the first day of its regular session in the second year  
12 following every census, and the Governor may call a special session for the presentation of  
13 his plan prior to the regular session. The plan shall conform to Sections 2, 3 and 4 of this  
14 Article. Following each decennial census the General Assembly may by joint resolution  
15 adopt a plan setting forth the boundaries of the legislative districts for the election of  
16 members of the Senate and the House of Delegates, which plan shall conform to Sections  
17 2, 3 and 4 of this Article. If a plan has been adopted by the General Assembly by the 45th  
18 day after the opening of the regular session of the General Assembly in the second year  
19 following every census, the plan adopted by the General Assembly shall become law. If no  
20 plan has been adopted by the General Assembly for these purposes by the 45th day after  
21 the opening of the regular session of the General Assembly in the second year following  
22 every census, the Governor's plan presented to the General Assembly shall become law.

23 Upon petition of any registered voter, the Court of Appeals shall have original  
24 jurisdiction to review the legislative districting of the State and may grant appropriate  
25 relief, if it finds that the districting of the State is not consistent with requirements of either  
26 the Constitution of the United States of America, or the Constitution of Maryland.]

28 **(A) IN THE YEAR FOLLOWING EACH DECENNIAL CENSUS OF THE UNITED**  
29 **STATES OR WHEN REQUIRED BY THE UNITED STATES OR BY COURT ORDER, A**  
30 **GENERAL ASSEMBLY AND CONGRESSIONAL LEGISLATIVE REDISTRICTING AND**  
31 **APPORTIONMENT COMMISSION SHALL BE APPOINTED:**

32 **(1) TO DIVIDE THE STATE INTO CONSECUTIVELY NUMBERED**  
33 **GENERAL ASSEMBLY LEGISLATIVE DISTRICTS THAT CONFORM TO SECTIONS 2, 3,**  
34 **AND 4 OF THIS ARTICLE; AND**

35 **(2) TO DIVIDE THE STATE TO CREATE AS MANY CONGRESSIONAL**  
36 **DISTRICTS AS THERE ARE REPRESENTATIVES IN CONGRESS APPORTIONED TO THE**  
37 **STATE.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read

10 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
11 INDICATED.

12 (B) “COMMISSION” MEANS THE GENERAL ASSEMBLY AND CONGRESSIONAL  
13 REDISTRICTING AND APPORTIONMENT COMMISSION.

14 (C) “DAY” MEANS A CALENDAR DAY, EXCEPT THAT IF THE FINAL DAY OF A  
15 PERIOD WITHIN WHICH AN ACT IS TO BE PERFORMED IS A SATURDAY, SUNDAY, OR  
16 HOLIDAY, THE PERIOD IS EXTENDED TO THE NEXT DAY THAT IS NOT A SATURDAY,  
17 SUNDAY, OR HOLIDAY.

18 (D) “PANEL” MEANS THE APPLICANT REVIEW PANEL.

19 (E) “QUALIFIED INDEPENDENT AUDITOR” MEANS AN AUDITOR WHO IS  
20 CURRENTLY LICENSED BY THE STATE AND HAS BEEN A PRACTICING INDEPENDENT  
21 AUDITOR FOR AT LEAST 10 YEARS BEFORE APPOINTMENT TO THE APPLICANT  
22 REVIEW PANEL.

24 IT IS THE INTENT OF THE GENERAL ASSEMBLY THAT NEITHER THE GENERAL  
25 ASSEMBLY LEGISLATIVE DISTRICTS NOR THE DISTRICTS FOR THE STATE’S  
26 REPRESENTATIVES IN THE UNITED STATES CONGRESS BE DRAWN FOR THE  
27 PURPOSE OF FAVORING OR DISCRIMINATING AGAINST AN INCUMBENT  
28 OFFICEHOLDER, A CANDIDATE, OR A POLITICAL PARTY.

29 **8-7A-03.**

30 (A) IN THE YEAR FOLLOWING THE YEAR IN WHICH THE NATIONAL CENSUS  
31 IS TAKEN UNDER THE DIRECTION OF CONGRESS AT THE BEGINNING OF EACH

1 DECADE, THE COMMISSION SHALL ADJUST THE BOUNDARY LINES OF GENERAL  
2 ASSEMBLY LEGISLATIVE AND CONGRESSIONAL DISTRICTS IN CONFORMANCE WITH  
3 THE FOLLOWING STANDARDS AND PROCESS:

4 (1) (I) EACH MEMBER OF THE SENATE OF MARYLAND SHALL BE  
5 ELECTED FROM A SINGLE-MEMBER DISTRICT; AND

6 (II) A MEMBER OF THE HOUSE OF DELEGATES MAY BE ELECTED  
7 FROM A SINGLE-MEMBER DISTRICT OR A THREE-MEMBER DISTRICT;

8 (2) EACH MEMBER OF CONGRESS SHALL BE ELECTED FROM A  
9 SINGLE-MEMBER DISTRICT;

10 (3) THE POPULATION OF EACH GENERAL ASSEMBLY LEGISLATIVE  
11 DISTRICT SHALL BE REASONABLY EQUAL IN POPULATION, BUT MAY NOT DEVIATE  
12 MORE THAN 2% IN POPULATION BETWEEN DISTRICTS;

13 (4) THE POPULATION OF ALL CONGRESSIONAL DISTRICTS SHALL BE  
14 EQUAL TO THE GREATEST EXTENT PRACTICABLE; AND

15 (5) GENERAL ASSEMBLY LEGISLATIVE DISTRICTS AND  
16 CONGRESSIONAL DISTRICTS SHALL COMPLY WITH THE REQUIREMENTS OF §  
17 8-7A-05(A) OF THIS SUBTITLE.

18 (B) (1) FOLLOWING THE CRITERIA SPECIFIED UNDER SUBSECTION (A) OF  
19 THIS SECTION, THE COMMISSION SHALL ADJUST THE BOUNDARY LINES ACCORDING  
20 TO THE CRITERIA SET FORTH AND PRIORITIZED IN THIS SUBTITLE.

21 (2) THE COMMISSION SHALL ISSUE WITH ITS FINAL MAPS A REPORT  
22 THAT:

23 (I) EXPLAINS THE BASIS ON WHICH THE COMMISSION MADE  
24 THE DECISIONS IN ACHIEVING COMPLIANCE WITH THE CRITERIA; AND

25 (II) INCLUDES DEFINITIONS OF THE TERMS AND STANDARDS  
26 USED IN DRAWING THE FINAL MAPS.

27 (C) GENERAL ASSEMBLY LEGISLATIVE DISTRICTS AND CONGRESSIONAL  
28 DISTRICTS SHALL BE NUMBERED CONSECUTIVELY COMMENCING AT THE  
29 NORTHWESTERN BOUNDARY OF THE STATE AND ENDING AT THE SOUTHEASTERN  
30 BOUNDARY.

31 (D) IN DEVELOPING THE MAPS, THE COMMISSION SHALL:

- 1           **(1) HOLD PUBLIC HEARINGS;**  
2           **(2) PROVIDE ACCESS TO REDISTRICTING DATA AND SOFTWARE; AND**  
3           **(3) OTHERWISE ENSURE FULL PUBLIC PARTICIPATION IN THE**  
4 **REDISTRICTING PROCESS.**

5 **8-7A-04.**

6           **(A) THE COMMISSION SHALL:**

- 7           **(1) CONDUCT AN OPEN AND TRANSPARENT PROCESS ENABLING FULL**  
8 **PUBLIC CONSIDERATION OF AND COMMENT ON THE DRAWING OF DISTRICT LINES;**  
9           **(2) DRAW GENERAL ASSEMBLY LEGISLATIVE DISTRICTS AND**  
10 **CONGRESSIONAL DISTRICT LINES ACCORDING TO THE REDISTRICTING CRITERIA**  
11 **SPECIFIED IN THIS SUBTITLE; AND**  
12           **(3) CONDUCT ITS BUSINESS WITH INTEGRITY AND FAIRNESS.**

13           **(B) (1) THE SELECTION PROCESS FOR THE COMMISSION IS DESIGNED TO**  
14 **PRODUCE A COMMISSION THAT IS INDEPENDENT FROM LEGISLATIVE INFLUENCE**  
15 **AND REASONABLY REPRESENTATIVE OF THE STATE'S DIVERSITY.**

16           **(2) THE COMMISSION SHALL CONSIST OF THE FOLLOWING NINE**  
17 **MEMBERS:**

18                   **(I) THREE MEMBERS REGISTERED WITH THE POLITICAL PARTY**  
19 **THAT HAS THE HIGHEST NUMBER OF REGISTERED VOTERS IN THE STATE;**

20                   **(II) THREE MEMBERS REGISTERED WITH THE POLITICAL PARTY**  
21 **THAT HAS THE SECOND-HIGHEST NUMBER OF REGISTERED VOTERS IN THE STATE;**  
22 **AND**

23                   **(III) THREE MEMBERS NOT REGISTERED WITH EITHER OF THE**  
24 **TWO POLITICAL PARTIES THAT HAVE THE HIGHEST AND SECOND-HIGHEST NUMBER**  
25 **OF REGISTERED VOTERS IN THE STATE.**

26           **(3) EACH MEMBER OF THE COMMISSION:**

27                   **(I) SHALL BE A VOTER WHO, FOR 5 OR MORE YEARS**  
28 **IMMEDIATELY PRECEDING THE DATE OF THE INDIVIDUAL'S APPOINTMENT, HAS**

1 BEEN REGISTERED CONTINUOUSLY IN THE STATE WITH THE SAME POLITICAL PARTY  
2 OR HAS BEEN UNAFFILIATED WITH A POLITICAL PARTY AND HAS NOT CHANGED  
3 POLITICAL PARTY AFFILIATION; AND

4 (II) 1. MAY NOT HAVE BEEN A CANDIDATE FOR ELECTION TO  
5 OR SERVED AS GOVERNOR, A MEMBER OF THE GENERAL ASSEMBLY, OR OF THE  
6 UNITED STATES CONGRESS FROM THIS STATE DURING THE 5 YEARS IMMEDIATELY  
7 PRECEDING THE DATE OF THE INDIVIDUAL'S APPOINTMENT, OR AN IMMEDIATE  
8 FAMILY MEMBER ESTABLISHED THROUGH BLOOD OR LEGAL RELATION OF SUCH  
9 CANDIDATE OR MEMBER;

10 2. MAY NOT BE A REGULATED LOBBYIST IN THIS STATE;  
11 AND

12 3. MAY NOT BE OR HAVE SERVED AS STAFF OR A  
13 CONSULTANT TO A PERSON UNDER A CONTRACT WITH, OR ANY PERSON WITH AN  
14 IMMEDIATE FAMILY RELATIONSHIP THROUGH BLOOD OR LEGAL RELATION TO, THE  
15 GOVERNOR, A MEMBER OF THE GENERAL ASSEMBLY, OR A MEMBER OF CONGRESS  
16 FROM THIS STATE.

17 (4) THE TERM OF OFFICE OF EACH MEMBER OF THE COMMISSION  
18 EXPIRES ON THE APPOINTMENT OF THE FIRST MEMBER OF THE SUCCEEDING  
19 COMMISSION.

20 (5) (I) SEVEN MEMBERS OF THE COMMISSION SHALL CONSTITUTE  
21 A QUORUM.

22 (II) SIX OR MORE AFFIRMATIVE VOTES OF THE COMMISSION  
23 SHALL BE REQUIRED FOR ANY OFFICIAL ACTION, INCLUDING ANY FINAL PROPOSED  
24 MAPS AND PLANS FOR GENERAL ASSEMBLY LEGISLATIVE DISTRICTS OR  
25 CONGRESSIONAL DISTRICTS ADOPTED BY THE COMMISSION.

26 (6) EACH MEMBER OF THE COMMISSION SHALL:

27 (I) APPLY THE PROVISIONS OF THIS SUBTITLE IN A MANNER  
28 THAT IS IMPARTIAL AND THAT REINFORCES PUBLIC CONFIDENCE IN THE INTEGRITY  
29 OF THE REDISTRICTING PROCESS; AND

30 (II) BE INELIGIBLE FOR A PERIOD OF 5 YEARS BEGINNING FROM  
31 THE DATE OF APPOINTMENT:

32 1. TO HOLD APPOINTIVE FEDERAL, STATE, OR LOCAL  
33 PUBLIC OFFICE;



1                   **2. TO SERVE AS PAID STAFF FOR THE GENERAL**  
2 **ASSEMBLY OR ANY INDIVIDUAL LEGISLATOR; OR**

3                   **3. TO REGISTER AS A FEDERAL, STATE, COUNTY, OR**  
4 **MUNICIPAL LOBBYIST IN THE STATE.**

6           **(A) (1) EACH GENERAL ASSEMBLY LEGISLATIVE DISTRICT SHALL**  
7 **COMPLY WITH ARTICLE III, §§ 2, 3, AND 4 OF THE MARYLAND CONSTITUTION.**

8                   **(2) EACH CONGRESSIONAL DISTRICT SHALL:**

9                           **(I) COMPLY WITH THE UNITED STATES CONSTITUTION;**

10                           **(II) COMPLY WITH THE FEDERAL VOTING RIGHTS ACT;**

11                           **(III) BE EQUAL IN POPULATION, EXCEPT WHERE DEVIATION IS**  
12 **REQUIRED TO COMPLY WITH THE FEDERAL VOTING RIGHTS ACT (42 U.S.C. SEC.**  
13 **1971 AND FOLLOWING) OR IS ALLOWABLE BY LAW;**

14                           **(IV) WITHOUT VIOLATING THE REQUIREMENTS OF THIS**  
15 **SECTION, RESPECT THE GEOGRAPHIC INTEGRITY OF ANY MUNICIPAL CORPORATION**  
16 **OR COUNTY, TO THE EXTENT POSSIBLE;**

17                           **(V) BE GEOGRAPHICALLY CONTIGUOUS; AND**

18                           **(VI) TO THE EXTENT PRACTICABLE, AND IF IT DOES NOT**  
19 **CONFLICT WITH THE CRITERIA SPECIFIED IN ITEMS (I) THROUGH (V) OF THIS**  
20 **PARAGRAPH, BE DRAWN TO ENCOURAGE GEOGRAPHIC COMPACTNESS SO THAT**  
21 **NEARBY AREAS OF POPULATION ARE NOT BYPASSED FOR MORE DISTANT**  
22 **POPULATION.**

23           **(B) THE PLACE OF RESIDENCE OF AN INCUMBENT OFFICEHOLDER OR THE**  
24 **CANDIDATE FOR A POLITICAL PARTY OR OF ANY OTHER PERSON MAY NOT BE**  
25 **CONSIDERED IN THE CREATION OF A MAP.**

26           **(C) BY SEPTEMBER 15 OF EACH YEAR ENDING IN THE NUMBER ONE, THE**  
27 **COMMISSION SHALL APPROVE A FINAL MAP THAT SEPARATELY SETS FORTH THE**  
28 **DISTRICT BOUNDARY LINES FOR THE MEMBERS OF THE GENERAL ASSEMBLY AND**  
29 **FOR THE MEMBERS OF THE UNITED STATES CONGRESS OF THIS STATE.**

1           **(D) (1) THE COMMISSION SHALL ISSUE WITH EACH FINAL MAP A REPORT**  
2 **THAT:**

3                           **(I) EXPLAINS THE BASIS ON WHICH THE COMMISSION MADE ITS**  
4 **DECISIONS TO ACHIEVE COMPLIANCE WITH THE CRITERIA SPECIFIED UNDER THIS**  
5 **SUBTITLE; AND**

6                           **(II) INCLUDES DEFINITIONS OF THE TERMS AND STANDARDS**  
7 **USED IN DRAWING EACH FINAL MAP.**

8                   **(2) ON ADOPTION, THE COMMISSION SHALL SUBMIT ITS CERTIFIED**  
9 **FINAL MAPS AND PLANS TO THE SECRETARY OF STATE.**

10 **8-7A-06.**

11           **(A) THE COMMISSION:**

12                           **(1) HAS THE SOLE LEGAL STANDING TO DEFEND ANY ACTION**  
13 **REGARDING A CERTIFIED FINAL MAP AND PLAN; AND**

14                           **(2) SHALL INFORM THE GENERAL ASSEMBLY IF THE COMMISSION**  
15 **DETERMINES THAT FUNDS OR OTHER RESOURCES PROVIDED FOR THE OPERATION**  
16 **OF THE COMMISSION ARE NOT ADEQUATE.**

17                   **(B) THE GENERAL ASSEMBLY SHALL PROVIDE ADEQUATE FUNDING TO**  
18 **DEFEND ANY ACTION REGARDING A CERTIFIED FINAL MAP AND PLAN.**

19 **8-7A-07.**

20           **(A) THE SECRETARY OF STATE SHALL FORWARD CERTIFIED FINAL MAPS**  
21 **AND PLANS SUBMITTED BY THE COMMISSION TO THE PRESIDING OFFICERS OF THE**  
22 **GENERAL ASSEMBLY FOR THE INTRODUCTION BY THE PRESIDING OFFICERS OF A**  
23 **SEPARATE BILL CONTAINING:**

24                           **(1) THE GENERAL ASSEMBLY LEGISLATIVE DISTRICT PLAN; AND**

25                           **(2) THE CONGRESSIONAL DISTRICT PLAN.**

26                   **(B) (1) A FINAL CERTIFIED MAP AND PLAN INTRODUCED BY THE**  
27 **PRESIDING OFFICERS OF THE GENERAL ASSEMBLY MAY NOT BE AMENDED.**

28                           **(2) A MEMBER OF THE GENERAL ASSEMBLY MAY NOT INTRODUCE A**  
29 **BILL CONTAINING A GENERAL ASSEMBLY LEGISLATIVE DISTRICT OR**

1 CONGRESSIONAL DISTRICT PLAN THAT IS DIFFERENT THAN THE CERTIFIED FINAL  
2 MAP AND PLANS PROPOSED BY THE COMMISSION AND INTRODUCED BY THE  
3 PRESIDING OFFICERS.

4 (c) (1) THE GENERAL ASSEMBLY MAY APPROVE OR REJECT A BILL FOR  
5 A GENERAL ASSEMBLY LEGISLATIVE DISTRICT OR CONGRESSIONAL DISTRICT MAP  
6 AND PLAN AS PROVIDED IN THIS SUBSECTION.

7 (2) (i) 1. TO ADOPT A MAP AND PLAN, EACH HOUSE OF THE  
8 GENERAL ASSEMBLY SHALL PASS THE BILL BY A VOTE OF THREE-FIFTHS OF THE  
9 MEMBERS OF THAT HOUSE.

10 2. ON PASSAGE BY THE GENERAL ASSEMBLY, THE BILL  
11 SHALL BE PRESENTED TO THE GOVERNOR FOR SIGNATURE OR VETO.

12 (ii) 1. IF THE GOVERNOR VETOES THE BILL AND THE  
13 GENERAL ASSEMBLY OVERRIDES THE VETO, THE BILL SHALL BECOME LAW, IN  
14 ACCORDANCE WITH ARTICLE II, § 17 OF THE MARYLAND CONSTITUTION.

15 2. IF THE GOVERNOR VETOES THE BILL AND THE

12 **IMMEDIATELY PRECEDING REDISTRICTING PROCESS, AS EACH AMOUNT IS**  
13 **ADJUSTED BY THE CUMULATIVE CHANGE IN THE MARYLAND CONSUMER PRICE**  
14 **INDEX OR ITS SUCCESSOR SINCE THE DATE OF THE IMMEDIATELY PRECEDING**  
15 **APPROPRIATION.**

16           **(D) THE COMMISSION, WITH FISCAL OVERSIGHT FROM THE DEPARTMENT**  
17 **OF BUDGET AND MANAGEMENT, SHALL HAVE PROCUREMENT AND CONTRACTING**  
18 **AUTHORITY AND MAY HIRE STAFF AND CONSULTANTS, INCLUDING LEGAL**  
19 **REPRESENTATION.**

20           SECTION 3. AND BE IT FURTHER ENACTED, That the General Assembly  
21 determines that the amendment to the Maryland Constitution proposed by this Act affects  
22 multiple jurisdictions and that the provisions of Article XIV, § 1 of the Maryland  
23 Constitution concerning local approval of constitutional amendments do not apply.

24           SECTION 4. AND BE IT FURTHER ENACTED, That the amendment to the  
25 Maryland Constitution proposed by Section 1 of this Act shall be submitted to the qualified  
26 voters of the State at the next general election to be held in November 2018 for their  
27 adoption or rejection pursuant to Article XIV of the Maryland Constitution. At that general  
28 election, the vote on this proposed amendment to the Constitution shall be by ballot, and  
29 upon each ballot there shall be printed the words "For the Constitutional Amendment" and  
30 "Against the Constitutional Amendment," as now provided by law. Immediately after the  
31 election, all returns shall be made to the Governor of the vote for and against the proposed  
32 amendment, as directed by Article XIV of the Maryland Constitution, and further  
33 proceedings had in accordance with Article XIV.

34           SECTION 5. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take  
35 effect on the taking effect of Section 1 of this Act. If Section 1 of this Act does not take effect,

1 Section 2 of this Act shall be abrogated and of no further force and effect.

2 SECTION 6. AND BE IT FURTHER ENACTED, That, except as provided in  
3 Sections 4 and 5 of this Act, this Act shall take effect June 1, 2017.
