## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Carroll County – Sheriff's Salary**

3 FOR the purpose of altering the salary of the Sheriff of Carroll County; providing for the  
4 application of this Act; and generally relating to the Sheriff of Carroll County.

5 BY repealing and reenacting, with amendments,  
6 Article – Courts and Judicial Proceedings  
7 Section 2–309(h)(1)  
8 Annotated Code of Maryland  
9 (2013 Replacement Volume and 2016 Supplement)

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
11 That the Laws of Maryland read as follows:

12 **Article – Courts and Judicial Proceedings**

13 2–309.

14 (h) (1) The Sheriff of Carroll County shall receive an annual salary [of] AS  
15 **FOLLOWS:**

16 **(I) \$90,000 beginning on December 1, 2014;**

17 **(II) \$100,000 BEGINNING DECEMBER 4, 2018; AND**

1 (III) \$110,000 BEGINNING DECEMBER 3, 2019, and thereafter.

2 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35  
3 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary  
4 or compensation of the Sheriff of Carroll County while serving in a term of office beginning  
5 before the effective date of this Act, but the provisions of this Act concerning the salary or  
6 compensation of the Sheriff of Carroll County shall take effect at the beginning of the next  
7 following term of office. This limitation does not apply to an individual appointed or elected  
8 after the effective date of this Act to fill out an unexpired term.

9 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
10 October 1, 2017.
