A BILL ENTITLED

1 AN ACT concerning

2 **Vital Records – Birth, Death, and Fetal Death Certificates – Fees**

3 FOR the purpose of limiting the circumstances under which a fee may be collected by the
4 Department of Health and Mental Hygiene or a local health department for a birth,
5 death, or fetal death certificate requested by an agency of the State or any of its
6 political subdivisions; and generally relating to fees for birth, death, and fetal death
7 certificates.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Health – General**

21 4–217.

22 (a) (1) Except as provided in subsection (b) of this section, the Secretary shall
23 provide, on request, any person authorized by regulations adopted under this subtitle with
24 a certified or abridged copy of a birth, death, or fetal death certificate registered under this
25 subtitle or of the certificate of a marriage performed after June 1, 1951.

1 (2) Except as provided in subsection (b) of this section, a local health
2 department may:

3 (i) Access electronically from the Department a certified or abridged
4 copy of a birth certificate registered under this subtitle; and

5 (ii) On request, provide any person authorized by regulations
6 adopted under this subtitle with a certified or abridged copy of a birth certificate registered
7 under this subtitle.

8 (c) (4) The Department or a local health department may collect a fee for a
9 certificate requested by an agency of the State or any of its political subdivisions **UNLESS**
10 **THE CERTIFICATE WAS REQUESTED BY:**

11 **(I) THE AGENCY AS PART OF THE CONDUCT OF THE AGENCY'S**
12 **OFFICIAL BUSINESS; OR**

13 **(II) A PUBLIC OFFICIAL OF THE AGENCY WHO REQUESTS THE**
14 **CERTIFICATE IN ORDER TO CARRY OUT THE DUTIES OR FUNCTIONS OF THE PUBLIC**
15 **OFFICIAL'S OFFICE.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2017.
