A BILL ENTITLED

1 AN ACT concerning

2 **St. Mary's County – Sheriff, County Treasurer, and State's Attorney – Salaries**

3 FOR the purpose of altering the salary of the Sheriff of St. Mary's County, the County
4 Treasurer of St. Mary's County, and the State's Attorney for St. Mary's County;
5 providing for the application of this Act; and generally relating to the salaries of
6 public officials of St. Mary's County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Courts and Judicial Proceedings**

4 2–309.

5 (t) (1) The annual salary of the Sheriff of St. Mary’s County shall be:

6 (i) \$100,000 for the calendar year 2015;

7 (ii) \$102,000 for the calendar year 2016;

8 (iii) \$104,040 for the calendar year 2017; and

9 (iv) **[\$106,120 for the calendar year 2018] BEGINNING IN**
10 **CALENDAR YEAR 2018, EQUAL TO THE SALARY OF A DEPARTMENT OF STATE POLICE**
11 **LIEUTENANT COLONEL (STEP 12).**

12 (2) The Sheriff shall devote full time to the duties of office.

13 **Article – Criminal Procedure**

14 15–419.

15 (a) This section applies only in St. Mary’s County.

16 (b) (1) (i) The State’s Attorney’s salary is **[90% of] EQUAL TO** the salary of
17 a **[judge of the District Court of Maryland] CIRCUIT COURT JUDGE** and shall be paid
18 biweekly.

19 (ii) A salary increase shall take effect at the beginning of the elected
20 term of office and may not increase during the term of office.

21 (2) (i) The county commissioners shall provide for the administrative
22 support staff, independent office facilities, office equipment, supplies, books, and other
23 items necessary for the operation of the office.

24 (ii) The State’s Attorney shall present vouchers to the county
25 commissioners for the payment of office expenses.

26 **Article – Local Government**

27 16–203.

28 (a) The annual salary of the County Treasurer of St. Mary’s County is:

- 1 (1) \$50,000 for calendar year 2015;
- 2 (2) \$50,500 for calendar year 2016;
- 3 (3) \$51,005 for calendar year 2017; and
- 4 (4) [~~\$51,515~~] **\$63,000** for calendar year 2018.

5 (b) The County Treasurer of St. Mary’s County shall devote full time to the duties
6 of office.

7 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35
8 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary
9 or compensation of the Sheriff of St. Mary’s County, the County Treasurer of St. Mary’s
10 County, or the State’s Attorney for St. Mary’s County while serving in a term of office
11 beginning before the effective date of this Act, but the provisions of this Act concerning the
12 salary or compensation of the Sheriff of St. Mary’s County, the County Treasurer of St.
13 Mary’s County, and the State’s Attorney for St. Mary’s County shall take effect at the
14 beginning of the next following term of office. This limitation does not apply to an individual
15 appointed or elected after the effective date of this Act to fill out an unexpired term.

16 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2017.
