- 1 (3) A fine imposed under this section shall be imposed subject to \S 10–1001 2 of the State Government Article.
- 3 (d) Fines collected under this section shall be paid into the general fund of the 4 county.
- 5 (e) The granting of probation before judgment to a license holder or an employee 6 of the license holder for a violation of § 6–304 of this article does not bar the Board from 7 proceeding administratively against the license holder for the violation.
