CHAPTER

1 AN ACT concerning

Baltimore County - Property Tax Credit - Fallen or Disabled Law Enforcement Officers and Rescue Workers - Acquisition of Dwelling

4 FOR the purpose of altering eligibility for a certain property tax credit against the county 5 or municipal corporation property tax imposed on certain residential property in 6 Baltimore County to include certain residential property owned or acquired by a 7 certain cohabitant of a certain fallen law enforcement officer or rescue worker under 8 certain circumstances; altering the time period within which a disabled law 9 enforcement officer or rescue worker, or the cohabitant or surviving spouse of a fallen 10 law enforcement officer or rescue worker, shall have acquired certain residential 11 property in Baltimore County in order to qualify for the credit; providing for the 12 application of this Act; and generally relating to a property tax credit for certain 13 residential property owned by certain disabled law enforcement officers or rescue 14 workers or the cohabitants or surviving spouses of certain fallen law enforcement officers or rescue workers. 15

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

22 That the Laws of Maryland read as follows:

- 1 Article - Tax - Property 2 9-210.3 (a) (1) In this section the following words have the meanings indicated. 4 "Cohabitant" means an individual who for a period of at least 180 days in the year before the death of a fallen law enforcement officer or rescue worker: 5 6 had a relationship of mutual interdependence with the fallen law 7 enforcement officer or rescue worker; and 8 (ii) resided with the fallen law enforcement officer or rescue worker 9 in the dwelling. "Disabled law enforcement officer or rescue worker" means an 10 (3)11 individual who: 12 (i) has been found to be permanently and totally disabled by an 13 administrative body or court of competent jurisdiction authorized to make such a determination: and 14 15 (ii) became disabled: 16 1. as a result of or in the course of employment as a law 17 enforcement officer or a correctional officer; or 2. 18 while in the active service of a fire, rescue, or emergency 19 medical service, unless the disability was the result of the individual's own willful 20misconduct or abuse of alcohol or drugs. 21**(4)** "Dwelling" means real property that: (i) 22 is the legal residence of a disabled law enforcement officer 1. or rescue worker, a surviving spouse, or a cohabitant; and 23242. is occupied by not more than two families. 25 "Dwelling" includes the lot or curtilage and structures necessary (ii) 26 to use the real property as a residence. "Fallen law enforcement officer or rescue worker" means an individual 27 (5)28 who dies:
- 29 (i) as a result of or in the course of employment as a law enforcement 30 officer or a correctional officer; or

(ii) while in the active service of a fire, rescue, or emergency medical service, unless the death was the result of the individual's own willful misconduct or abuse of alcohol or drugs.

- (6) "Surviving spouse" means a surviving spouse, who has not remarried, of a fallen law enforcement officer or rescue worker.
- (b) The Mayor and City Council of Baltimore City or the governing body of a county or municipal corporation may grant, by law, a property tax credit under this section against the county or municipal corporation property tax imposed on a dwelling that is owned by a disabled law enforcement officer or rescue worker, a surviving spouse of a fallen law enforcement officer or rescue worker, or a cohabitant:
- (1) if the dwelling was owned by the disabled law enforcement officer or rescue worker at the time the law enforcement officer or rescue worker was adjudged to be permanently and totally disabled or by the fallen law enforcement officer or rescue worker at the time of the fallen law enforcement officer's or rescue worker's death;
- (2) (i) EXCEPT AS PROVIDED IN ITEM (II) OR (III) OF THIS ITEM, if the disabled law enforcement officer or rescue worker was domiciled in the State as of the date the disabled law enforcement officer or rescue worker was adjudged to be permanently and totally disabled or the fallen law enforcement officer or rescue worker, or the surviving spouse was domiciled in the State as of the date of the fallen law enforcement officer's or rescue worker's death and the dwelling was acquired by the disabled law enforcement officer or rescue worker within 2 years of the date the disabled law enforcement officer or rescue worker was adjudged to be permanently and totally disabled or by the surviving spouse within 2 years of the fallen law enforcement officer's or rescue worker's death; [or]
- (ii) **BALTIMORE** COUNTY, \mathbf{IF} THE **DISABLED** IN ENFORCEMENT OFFICER OR RESCUE WORKER WAS DOMICILED IN THE STATE AS OF THE DATE THE DISABLED LAW ENFORCEMENT OFFICER OR RESCUE WORKER WAS ADJUDGED TO BE PERMANENTLY AND TOTALLY DISABLED OR THE FALLEN LAW ENFORCEMENT OFFICER OR RESCUE WORKER, THE SURVIVING SPOUSE, OR COHABITANT WAS DOMICILED IN THE STATE AS OF THE DATE OF THE FALLEN LAW ENFORCEMENT OFFICER'S OR RESCUE WORKER'S DEATH AND THE DWELLING WAS ACQUIRED BY THE DISABLED LAW ENFORCEMENT OFFICER OR RESCUE WORKER AFTER THE DATE THE DISABLED LAW ENFORCEMENT OFFICER OR RESCUE WORKER WAS ADJUDGED TO BE PERMANENTLY AND TOTALLY DISABLED OR BY THE COHABITANT OR SURVIVING SPOUSE AFTER THE FALLEN LAW ENFORCEMENT OFFICER'S OR RESCUE WORKER'S DEATH; OR
- (III) in Harford County, if the disabled law enforcement officer or rescue worker was domiciled in the State as of the date the disabled law enforcement officer or rescue worker was adjudged to be permanently and totally disabled or the fallen law enforcement officer or rescue worker, the surviving spouse, or cohabitant was domiciled in the State as of the date of the fallen law enforcement officer's or rescue worker's death and
