A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Caregivers Support Coordinating Council – Renaming and Altering**
3 **Membership and Duties**

4 FOR the purpose of renaming the Maryland Caregivers Support Coordinating Council to
5 be the Maryland Commission on Caregiving; altering the membership of the
6 Commission to include certain members of the General Assembly; requiring the
7 Governor to consider groups representing certain individuals when appointing
8 members to the Commission; requiring the Commission to provide ongoing analysis
9 of best practices in family caregiver support programs and to monitor
10 implementation of the Commission's recommendations; making certain conforming
11 changes; and generally relating to the Maryland Commission on Caregiving.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

24 **Article – Human Services**

1 (a) In this subtitle the following words have the meanings indicated.

2 (b) ["Council"] "COMMISSION" means the [Maryland Caregivers Support
3 Coordinating Council] **MARYLAND COMMISSION ON CAREGIVING.**

4 (c) "Department" means the Department of Human Resources.

5 7-302.

6 (a) There is a [Maryland Caregivers Support Coordinating Council] **MARYLAND**
7 **COMMISSION ON CAREGIVING** in the Department.

8 (b) The purpose of the [Council] **COMMISSION** is to coordinate statewide
9 planning, development, and implementation of family caregiver support services.

10 7-303.

11 (a) (1) The [Council] **COMMISSION** consists of the following members
12 [appointed by the Governor]:

13 (I) **ONE MEMBER OF THE SENATE OF MARYLAND, APPOINTED**
14 **BY THE PRESIDENT OF THE SENATE;**

15 (II) **ONE MEMBER OF THE HOUSE OF DELEGATES, APPOINTED**
16 **BY THE SPEAKER OF THE HOUSE; AND**

17 (III) **THE FOLLOWING MEMBERS APPOINTED BY THE GOVERNOR:**

18 [(i)] **1.** two representatives from the Department of Human
19 Resources;

20 [(ii)] **2.** three representatives from the Department of Health and
21 Mental Hygiene;

22 [(iii)] **3.** one representative from the Department of Aging;

23 [(iv)] **4.** one representative from an area agency on aging;

24 [(v)] **5.** one representative from the Department of Disabilities;

25 [(vi)] **6.** one representative from the Maryland Respite Care
26 Coalition;

27 [(vii)] **7.** two consumers of respite care services;

1 [(viii)] **8.** three family caregivers; and

2 [(ix)] **9.** three representatives of organizations that provide or
3 have interest or expertise in respite care services.

4 (2) In appointing members to the [Council] **COMMISSION**, to the extent
5 possible, the Governor shall consider groups representing individuals [with]:

6 (i) **WITH** Alzheimer's disease and related disorders;

7 (ii) **WITH** developmental disabilities;

8 (iii) **WITH** physical disabilities;

9 (iv) **WITH** chronic illnesses;

10 (v) **WITH** mental or emotional conditions that require supervision;

11 [and]

12 (vi) **[vulnerability] WHO ARE VULNERABLE** to abuse or neglect;

13 **(VII) WITH DISABILITIES, DISORDERS, OR CONDITIONS**
14 **AFFECTING THE ENTIRE LIFESPANS OF THE INDIVIDUALS; AND**

15 **(VIII) WHO REFLECT THE DIVERSITY OF THE STATE.**

16 (b) The term of a member of the [Council] **COMMISSION** is 3 years.

17 (c) The Governor shall appoint a chair of the [Council] **COMMISSION** from
18 among the members.

20 (a) (1) The Department shall provide staff for the [Council] **COMMISSION**.

21 (2) An individual from the Department shall serve as executive director of
22 the [Council] **COMMISSION**.

23 (b) A member of the [Council] **COMMISSION**:

24 (1) may not receive compensation as a member of the [Council]
25 **COMMISSION**; but

26 (2) is entitled to reimbursement for expenses under the Standard State
27 Travel Regulations, as provided in the State budget.

2 (a) The [Council] COMMISSION shall:

3 (1) solicit and gather concerns of caregivers by:

4 (i) conducting surveys;

5 (ii) holding public hearings;

6 (iii) establishing a telephone hotline for public access; and

7 (iv) other appropriate means;

8 (2) develop and distribute to interested parties a handbook of current
9 respite care and other family caregiver services available in the State;

10 (3) review successful respite care programs in other states;

11 (4) develop a model family caregiver support program that incorporates
12 best practices from existing programs in this and other states;

13 **(5) PROVIDE ONGOING ANALYSIS OF BEST PRACTICES IN FAMILY**
14 **CAREGIVER SUPPORT PROGRAMS IN THIS AND OTHER STATES;**

15 **[(5)] (6)** coordinate activities of existing and proposed family caregiver
16 support services among State and local units;

17 **[(6)] (7)** research available funding sources and explore possibilities for
18 additional funds; [and]

19 **[(7)] (8)** identify unmet needs and priorities for additional funds; **AND**

20 **(9) MONITOR IMPLEMENTATION OF THE COMMISSION'S**
21 **RECOMMENDATIONS.**

22 (b) The [Council] COMMISSION shall report annually on its activities **AND**
23 **RECOMMENDATIONS REGARDING FAMILY CAREGIVER SUPPORT SERVICES** to the
24 Governor and, subject to § 2-1246 of the State Government Article, the General Assembly.

25 10-702.

26 (a) There is a Family Caregiver Assistance Program in the Department.

1 (b) The purpose of the Program is to provide grants to eligible family caregivers
2 to supplement the unmet expenses of caring for an adult dependent.

3 10-705.

4 The Secretary shall:

5 (2) work in cooperation with the Department of Disabilities, the
6 Department of Health and Mental Hygiene, and the [Maryland Caregivers Support
7 Coordinating Council] **MARYLAND COMMISSION ON CAREGIVING** to promote the
8 Program to family caregivers throughout the State; and

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 October 1, 2017.
