A BILL ENTITLED

1 AN ACT concerning

2 **Howard County – Alcoholic Beverages – Thresholds for Tasting**

3 **Ho. Co. 19–17**

4 FOR the purpose of altering certain thresholds for the amount of alcoholic beverages that a
5 holder of a beer and wine tasting license in Howard County may serve for on–premises
6 consumption; altering certain thresholds for the amount of alcoholic beverages that a
7 holder of a beer, wine, and liquor tasting license in Howard County may serve for
8 on–premises consumption; and generally relating to alcoholic beverages licenses in
9 Howard County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Alcoholic Beverages**

23 23–102.

24 This title applies only in Howard County.

2 (a) There is a beer and wine tasting (BWT) license.

3 (b) The Board may issue the license to a holder of a Class A beer, wine, and liquor
4 (BWL) license or Class A beer and wine (BW) license.

5 (c) The license authorizes the holder to allow the on-premises consumption, for
6 tasting, of:

7 (1) beer; or

8 (2) wine containing not more than 15.5% of alcohol by volume.

9 (d) A license holder may serve:

10 (1) wine in a quantity of not more than [1 ounce] **2 OUNCES** from each
11 offering and not more than [4] **8** ounces from all offerings to an individual in a day; or

12 (2) beer in a quantity of not more than [3] **6** ounces from each offering and
13 not more than [8] **16** ounces from all offerings to an individual in a day.

14 (e) In addition to the fee of any other alcoholic beverages license, the annual
15 license fee is \$100.

16 23-1308.

17 (a) There is a beer, wine, and liquor tasting (BWLTL) license.

18 (b) The Board may issue the license to a holder of a Class A beer, wine, and liquor
19 (BWL) license.

20 (c) The license authorizes the holder to allow the on-premises consumption, for
21 tasting, of:

22 (1) beer;

23 (2) wine containing not more than 15.5% of alcohol by volume; or

24 (3) liquor.

25 (d) A license holder may serve:

26 (1) wine in a quantity of not more than [1 ounce] **2 OUNCES** from each
27 offering and not more than [4] **8** ounces from all offerings to an individual in a day;

1 (2) beer in a quantity of not more than [3] **6** ounces from each offering and
2 not more than [8] **16** ounces from all offerings to an individual in a day; or

3 (3) liquor in a quantity of not more than [1/4] **1/2** ounce from each offering
4 and not more than [1 ounce] **2 OUNCES** from all offerings to an individual in a day.

5 (e) In addition to any other alcoholic beverages license fee, the annual license fee
6 is \$100.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
8 1, 2017.
