# Public Safety – Maryland Police Training and Standards Commission – Psychological Evaluations of Law Enforcement Officers

FOR the purpose of requiring the Maryland Police Training and Standards Commission to
develop standards for the periodic psychological evaluation of all law enforcement
officers, if determined by the Commission to be appropriate; and generally relating
to the Maryland Police Training and Standards Commission.

- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
   14 That the Laws of Maryland read as follows:
- 15 Article Public Safety
  - 16 3–207.

17 (a) The Commission has the following powers and duties:

18 (1) to establish standards for the approval and continuation of approval of 19 schools that conduct police entrance–level and in–service training courses required by the 20 Commission, including State, regional, county, and municipal training schools;

1 (9) to conduct and operate police training schools authorized by the 2 Commission to offer police training programs;

3 (10) to make a continuous study of entrance-level and in-service training 4 methods and procedures;

5 (11) to consult with and accept the cooperation of any recognized federal, 6 State, or municipal law enforcement agency or educational institution;

7 (12) to consult and cooperate with universities, colleges, and institutions in 8 the State to develop specialized courses of study for police officers in police science and 9 police administration;

10 (13) to consult and cooperate with other agencies and units of the State 11 concerned with police training;

12 (14) to develop, with the cooperation of the Office of the Chief Medical 13 Examiner and the Federal Bureau of Investigation, a uniform missing person report form 14 to be available for use by each law enforcement agency of the State on or before October 1, 15 2008;

16 (15) to require, for entrance-level police training and annually for 17 in-service level police training conducted by the State and each county and municipal police 18 training school, that the curriculum and minimum courses of study include, for police 19 officers who are issued an electronic control device by a law enforcement agency, special 20 training in the proper use of electronic control devices, as defined in § 4–109 of the Criminal 21 Law Article, consistent with established law enforcement standards and federal and State 22 constitutional provisions;

(16) to require, for entrance-level police training and, as determined by the Commission, for in-service level training conducted by the State and each county and municipal police training school, that the curriculum and minimum courses of study include, consistent with established law enforcement standards and federal and State constitutional provisions:

(i) training in lifesaving techniques, including Cardiopulmonary
 Resuscitation (CPR);

1 (17) to require, for entrance-level police training and at least every 2 years 2 for in-service level police training conducted by the State and each county and municipal 3 police training school, that the curriculum and minimum courses of study include special 4 training, attention to, and study of the application of antidiscrimination and use of force 5 de-escalation training;

6 (18) to develop, with the cooperation of the Office of the Attorney General, 7 the Governor's Office of Crime Control and Prevention, and the Federal Trade Commission, 8 a uniform identity fraud reporting form that:

9 (i) makes transmitted data available on or before October 1, 2011, 10 for use by each law enforcement agency of State and local government; and

(ii) may authorize the data to be transmitted to the ConsumerSentinel program in the Federal Trade Commission;

13 (19) to adopt and recommend a set of best practices and standards for use of14 force;

15 (20) to evaluate and modernize recruitment standards and practices of law 16 enforcement agencies to increase diversity within those law enforcement agencies and 17 develop strategies for recruiting women and African American, Hispanic or Latino, and 18 other minority candidates;

(I) the mandatory psychological evaluation of a law enforcement
 officer who was actively involved in an incident when another person was seriously injured
 or killed as a result of an accident or a shooting or has returned from combat deployment;

### 24 (II) THE PERIODIC PSYCHOLOGICAL EVALUATION OF ALL LAW 25 ENFORCEMENT OFFICERS, IF DETERMINED BY THE COMMISSION TO BE 26 APPROPRIATE;

(i) a statement condemning motorcycle profiling to be included in
 existing written policies regarding other profiling; and
