CHAPTER _____

1 AN ACT concerning

2 **State Retirement and Pension System – Death Benefits**

3 FOR the purpose of allowing a certain surviving dependent parent of a member of the
4 Correctional Officers' Retirement System to participate in the State Employee and
5 Retiree Health and Welfare Benefits Program if the surviving dependent parent
6 receives a certain allowance; altering the requirements for a certain surviving minor
7 child to participate in the State Employee and Retiree Health and Welfare Benefits
8 Program if the surviving child receives a certain allowance; altering the distribution
9 of certain survivor benefits to surviving children of certain members of the State
10 Retirement and Pension System; requiring a surviving disabled child to receive
11 certain survivor benefits; allowing a certain death benefit to be paid if certain special
12 death benefits are waived by certain individuals; altering the distribution of certain
13 special death benefits to certain surviving children of certain members of the State
14 Retirement and Pension System; requiring a surviving disabled child to receive
15 certain special death benefits; providing for the distribution of certain special death
16 benefits to surviving children; requiring a surviving dependent parent to receive
17 certain special death benefits; requiring certain death benefits to be paid if the
18 payment of certain special death benefits are waived by certain individuals; making
19 conforming changes; providing for the application of this Act; and generally relating
20 to death benefits in the State Retirement and Pension System.

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
9 That the Laws of Maryland read as follows:

10 **Article – State Personnel and Pensions**

11 2–507.

12 (a) Subject to the regulations adopted under § 2–503 of this subtitle, a State
13 employee may enroll and participate in any of the health insurance or other benefit options
14 established under the Program.

15 (b) The surviving spouse of a State employee who died while employed by the
16 State may enroll and participate in the health insurance benefit options established under
17 the Program as long as the surviving spouse:

18 (1) is receiving an allowance under Title 29, Subtitle 2 of this article; or

19 (2) is the sole primary designated beneficiary and receiving a periodic
20 distribution of benefits under an optional retirement program under Title 30 of this article.

21 (c) The surviving [minor] child or dependent parent of a State Police officer who
22 died while employed by the State may enroll and participate in the health insurance benefit
23 options established under the Program as long as the child or parent is receiving an
24 allowance under Title 29, Subtitle 2 of this article.

25 (d) The surviving [minor] child **OR DEPENDENT PARENT** of a correctional officer
26 who at the time of death was a member of the Correctional Officers' Retirement System
27 and who died while employed by the State may enroll and participate in the health
28 insurance benefit options established under the Program as long as the child **OR PARENT**
29 is receiving an allowance under Title 29, Subtitle 2 of this article.

30 (e) The surviving [minor] child or dependent parent of a State employee who at
31 the time of death was a member of the Employees' Retirement System, Employees' Pension
32 System, Teachers' Retirement System, or Teachers' Pension System and who was killed
33 while employed by the State may enroll and participate in the health insurance benefit
34 options established under the Program as long as the child or parent is receiving an
35 allowance under Title 29, Subtitle 2 of this article.

1 24-403.

2 (a) This section applies only to a retiree who has retired with a service retirement
3 allowance or a disability retirement allowance or a former member who has retired with a
4 deferred vested allowance.

5 (b) On the death of a retiree or former member, the Board of Trustees shall pay
6 80% of the retiree's retirement allowance:

7 (1) to the surviving spouse; or

8 (2) if there is [not a] **NO** surviving spouse [or], if the surviving spouse dies
9 before the youngest child is [18] **26** years old, **OR THERE IS A SURVIVING DISABLED**
10 **CHILD**, to any children of the deceased retiree [who are under 18 years of age] **IN**
11 **ACCORDANCE WITH SUBSECTION (C) OF THIS SECTION.**

1 (a) This section applies to the surviving spouse or a child of a retiree in receipt of
2 a service retirement allowance or a disability retirement allowance.

3 (b) On the death of a retiree, the Board of Trustees shall pay 50% of the retiree's
4 retirement allowance to:

5 (1) the surviving spouse; or

6 (2) if there is no surviving spouse [or], if the surviving spouse dies before
7 the youngest child of the retiree is [18] **26** years old, [all] **OR THERE IS A SURVIVING**
8 **DISABLED CHILD, ANY** children of the deceased retiree [who are under 18 years old] **IN**
9 **ACCORDANCE WITH SUBSECTION (C) OF THIS SECTION.**

30 (a) (1) Except as provided in paragraph (2) of this subsection, on the death of
31 a member, the Board of Trustees shall pay to the surviving spouse 50% of the retirement
32 allowance that would be payable were the member alive and eligible to receive a retirement
33 allowance.

1 (2) (i) If at the time of death the member does not have a surviving
2 spouse, the Board of Trustees shall pay to the member's designated beneficiary or
3 beneficiaries a lump-sum death benefit consisting of the sum of:

- 4 1. the member's accumulated contributions; and
5 2. an amount equal to the member's annual salary at the
6 time of death.

7 (ii) If a member has designated more than one beneficiary, the
8 lump-sum death benefit provided in subparagraph (i) of this paragraph shall be divided
9 equally among the beneficiaries.

10 (b) On the death of a former member or retiree, the Board of Trustees shall pay
11 to the surviving spouse 50% of the retirement allowance that would be payable were the
12 former member or retiree alive and eligible to receive a retirement allowance.

13 (c) (1) This subsection applies to a member, former member, or retiree who at
14 the time of death:

- 15 (i) does not have a spouse; and
16 (ii) has a child under the age of [18] **26** years, **OR A CHILD WHO IS**
17 **DISABLED.**

18 (2) [Until each child reaches the age of 18 years, the] **THE** Board of
19 Trustees shall pay to the surviving children of the member, former member, or retiree [who
20 are under the age of 18 years] the retirement allowance that would have been paid to a
21 surviving spouse under subsection (a) or (b) of this section, **SUBJECT TO PARAGRAPH (3)**
22 **OF THIS SUBSECTION.**

23 (3) **(I) [If] EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**
24 **PARAGRAPH, IF** the Board of Trustees pays an allowance to more than one child, the Board
25 of Trustees shall divide the allowance equally among the children [who are under the age
26 of 18 years becomes 18 years old] **IN A MANNER THAT PROVIDES FOR PAYMENTS TO**
27 **CONTINUE UNTIL:**

- 28 1. **ALL SURVIVING CHILDREN HAVE DIED; OR**

15 (a) (1) When the Board of Trustees receives proof of death of an individual who
16 died while employed as a member, the Board of Trustees shall pay to the designated
17 beneficiary or, if there is no designated beneficiary, to the member's estate the amounts
18 specified in this subsection.

19 (2) Subject to paragraph (1) of this subsection, the Board of Trustees shall
20 pay the member's accumulated contributions.

21 (3) Subject to paragraph (1) of this subsection, the Board of Trustees shall
22 pay an amount equal to the member's annual earnable compensation at death if the
23 member dies in the course of the performance of duty or the member has at least 1 year of
24 eligibility service.

25 (b) (1) A death benefit under this section may not be paid for the death of a
26 member of the State Police Retirement System if a special death benefit under § 29–204 of
27 this subtitle is [payable or has been] paid for that death.

28 (2) A death benefit under this section may not be paid for the death of a
29 member of the Correctional Officers' Retirement System if a special death benefit under §
30 29–204.1 of this subtitle is [payable or has been] paid for that death.

31 (3) A death benefit under this section may not be paid for the death of a
32 member of the Employees' Retirement System, Employees' Pension System, Teachers'
33 Retirement System, or Teachers' Pension System if a special death benefit under §
34 29–204.2 of this subtitle is [payable or has been] paid for that death.

1 (4) A death benefit under this section may not be paid for the death of a
2 member of the Law Enforcement Officers' Pension System if a special death benefit under
3 § 29-203 of this subtitle is [payable or has been] paid for that death.

4 (5) IF ALL INDIVIDUALS WHO ARE ELIGIBLE FOR A SPECIAL DEATH
5 BENEFIT UNDER § 29-203, § 29-204, § 29-204.1, OR § 29-204.2 ELECT TO WAIVE THE
6 PAYMENT OF A SPECIAL DEATH BENEFIT, A BENEFIT SHALL BE PAID IN
7 ACCORDANCE WITH SUBSECTION (A) OF THIS SECTION.

8 (c) The Board of Trustees may provide the death benefit as group life insurance
9 if the Board of Trustees finds that the designated beneficiaries would receive a more
10 favorable tax treatment of the death benefit.
